Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Court met in

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the Court reconvened in Regular Session at 5:20 P.M.

(3) ACTION RELATIVE TO EXECUTIVE SESSION

Judge Hinojosa recommended that County Counsel should be authorized to settle the case with Ms. Mary Lou Munivez, in the

sum of \$25,000.00, disposing of any and all claims pending in the Court plus, any and all claims which she may have

against the County regarding said matter.

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, County Counsel was

authorized to settle the case with Ms. Mary Lou Munivez, in the amount of \$25,000.00, disposing of any an all claims

pending in the Court, plus any and all claims against the County regarding the case styled Mary Lou Munivez vs. Luis

V. Saenz, B-96-032, in the United States District Court for the Southern District of Texas.

b) Confer with County Counsel to discuss the possible lease for the Justice of the Peace, the Constable Precinct No. 1, the

At this time, Commissioner Cascos clarified that the reason for his opposition was due to the parking situation of the building

and explained that the Lessor acknowledged that he would provide additional parking, but noted that the parking area

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the Status Report by

County Counsel was acknowledged regarding the possible litigation between Cameron County and the Professional

Computer Software Services.

j) Deliberation regarding the Real Property concerning the possible purchase of 1.5 acres located at J.

C. Dunn Business Park, La Feria, Cameron County, Texas.

Judge Hinojosa recommended that the property be purchased, in the amount of \$50,000.00, and that County Counsel should be

authorized to prepare the necessary documents regarding said matter.

At this time, Judge Hinojosa explained that the property was being purchased, in order to construct a County Building which

would contain the Offices of the Justice of the Peace, the Constable, the Sheriff, the Tax Assessor-Collector and the

County Clerk-s Office. He added that the Department of Public Safety would possibly be housed at said building as

well as any interested State Law Enforcement Agencies.

Commissioner Peña moved that the Real Property of 1.5 acres, located at J. C. Dunn Business Park, La Feria, Cameron

County, Texas, be purchased and that County Counsel be authorized to prepare the necessary documents.

The motion was seconded by Commissioner Cascos and carried unanimously.

(9) AUTHORIZATION TO APPOINT MR. DAVID WISE TO

THE VACANT JUSTICE OF THE PEACE POSITION OF

PRECINCT NO. 5, PLACE 2

Commissioner Peña moved that Mr. David Wise, Harlingen, Texas, be appointed to the vacant Justice of the Peace

Position of Precinct No. 5, Place 2.

The motion was seconded by Commissioner Benavides and carried as follows:

AYE: Commissioners Benavides, Peña and Judge Hinojosa

NAY: None

ABSTAINED: Commissioner Cascos.

At this time, Commissioner Cascos stated that the suggestion had been discussed to assess the Justices of the Peace Positions Countywide and added that a study should have been done to redistrict and realign the Justices of the Peace Positions.

At this time, Judge David Wise, Justice of the Peace Precinct No. 5, Place 2, expressed his gratitude to the Court, the Selection Committee, and the community and briefly highlighted his career and accomplishments.

At this time, Mr. Manny Vela, Attorney at Law, presented the following Members of the Selection Committee:

(10) IN THE MATTER OF THE CAMERON COUNTYINSURANCE COMMITTEE S
RECOMMENDATION OF THE EMPLOYEES BENEFITS/HEALTH INSURANCE PROGRAM AND AUTHORIZATION TO NEGOTIATE THE CONTRACT (TABLED)

At this time, Mr. Mark Yates, County Auditor, explained that the current Health Insurance carrier had not provided satisfactory service to the County regarding the payment of claims, and added that the Insurance Committee had interviewed six (6) insurance companies to serve as the Insurance Administrator. He stated that said companies were not a hundred percent (100%) compatible with the current carrier and recommended that the County should retain the current carrier on a quarterly basis, in order to extend more time to continue the review process, due to the time frame of the Insurance Anniversary on May 1, 1997.

Commissioner Cascos expressed concern whether the recommendation was the consensus of the Committee Members to retain the current carrier and questioned the time frame.

Mr. Yates responded that an outside consultant was utilized in the assessment of the Proposals and stated that the members present could express their point of views if they differed.

Judge Hinojosa clarified that the recommendation of the County Auditor was to retain Anthem Health Insurance on a quarterly basis and examine if the problems would be corrected, noting his opposition to the recommendation.

At this time, Judge Darrell Hester, 197th District Court, stated that the Anthem Health Insurance had recently retained a new Chief Executive Officer and had acknowledged the problems and had presented fair and impressive commitments to improve the service to the County. He added that the carrier had agreed to continue with the County on a three (3) month basis upon satisfaction of the County and stated that the time would allow the Committee to review and reconcile the Proposals.

Commissioner Cascos clarified that the understanding was that the Committee was unanimously recommending the current carrier for ninety (90) days and that the Proposals received were not parallel to the current carrier, noting that the request of the Insurance Committee should be honored.

Judge Hinojosa expressed his opposition as to the utilization of the outside consultant and the current insurance carrier and added that the company had made many commitments when they were hired that were not fulfilled. He stated that the consequences were severe to the County, if the company was retained, and recommended that only one (1) quarter should be given to the current carrier, in order to allow the Commissioners=Court to schedule a workshop to discuss the matter. Judge Hinojosa added that the Proposals narrowed down by the Committee should be presented to the Court to be reviewed for a final decision.

Commissioner Cascos questioned whether the current provider was on the Ashort list@ to be presented to the Court and the County Auditor responded that the current provider was on the short list. Commissioner Cascos expressed concern to whether the company would be automatically excluded from the list due to their quality of service.

Judge Hinojosa proposed that short list be reviewed, with or without the current provider, and that the ninety (90) day extension be made, in order to schedule the Workshop.

Commissioner Peña questioned the May 1, 1997 deadline and the County Auditor responded that the May 1, 1997, deadline was an anniversary, in which enrollment commenced, noting that there would be two (2) enrollments for this year due to the situation.

Mr. Yates stated that the Anthem Health Insurance premium was going to increase and that it would cost the County an additional 5.4% in the subsequent years Budget, plus \$200.00 per head annually for the Insurance Policy. He reported that Anthem Health Insurance offered the lowest interest rate compared to the other proposed companies.

Commissioner Cascos suggested that the Health Insurance Committee should take an active role at the Workshop, in order to assist the Court in reaching a consensus in determining the best Proposal.

At this time, Judge Hinojosa recommended that the Item be Tabled with the understanding that the Commissioners would accept the short list recommended by the Committee and that a Workshop be scheduled, within the next thirty (30) days, to allow the presentations to be made, as to the needs of the County. He added that the County should request that the Anthem Health Insurance extend their services for a period of ninety (90) days, noting that if the request was denied, the company would be removed from the short list.

Mr. Doug Wright, Cameron County Counsel, stated that the Court needed to address the issue of the recommendation made by the Committee as reflected on the Agenda Item.

Judge Hinojosa clarified that the recommendations by the Court were being instructed to the County Auditor, in terms of scheduling the Workshop and discussing the matter with the Anthem Health Insurance Company and that the process was simply being explained.

Mr. Yates stated that he would report the response of the Anthem Health Insurance Company to the Court and would assist the County Judge-s Office in setting up the Workshop.

Upon motion by Commissioner Peña, seconded by Commissioner Cascos and carried unanimously, this Item was (TABLED).

(7) ADOPTION OF A PROCLAMATION DESIGNATING APRIL 5, 1997, THROUGH APRIL 11, 1997, AS ACOMMUNITIES IN SCHOOLS WEEK® IN CAMERON COUNTY

At this time, Mr. Ricardo Gonzalez, San Benito Independent School District, briefly highlighted the activities and the vision of the ACommunities in Schools Week@.

Commissioner Benavides moved that the Proclamation designating April 5, 1997, through April 11, 1997, as ACommunities in Schools Week@ in Cameron County, be adopted.

The motion was seconded by Commissioner Peña and carried unanimously.

The Proclamation is as follows:

(32) AUTHORIZATION TO INCREASE THE AUTO ALLOWANCE FOR DEPUTY CONSTABLES FOR PRECINCT NO. 2 AND PRECINCT NO. 4

At this time, Constable Conrado Cantu, Precinct No. 2, highlighted the duties and the areas being patrolled by the Deputies, which required constant travel.

Commissioner Benavides moved that the auto allowance be increased for Deputy Constables Precinct No. 2 and Precinct No. 4.

The motion was seconded by Commissioner Cascos and carried unanimously.

(4) APPROVAL OF COUNTY CLAIMS

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the County Claims were approved as presented by the County Auditor.

At this time, the County Auditor reported that there were no Budget Amendments and/or Salary Schedules for approval.

(6) IN THE MATTER OF THE MINUTES OF MARCH 25, 1997, AND APRIL 1, 1997 (TABLED)

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, this Item was (TABLED).

(11) AUTHORIZATION TO COMMENCE THE NEGOTIATIONS WITH BI-TECH AND HEWLETT-PACKARD/IBM TO ENTER INTO A CONTRACT FOR THE PURCHASING AND FINANCING OF A FINANCIAL, HUMAN RESOURCE, WORK ORDER SYSTEM, BUDGETING, GRANT MANAGEMENT, AND JOB/PROJECT, LEDGER ACCOUNTING PROGRAM

At this time, Mr. Mark Yates, County Auditor, stated that the cost of the program needed to be further negotiated and explained that the total price of the Project would cost the amount of \$400,000.00, which could be allocated through grants and various funds, noting that the main benefits to the County would be the Remote Requisition and a Work Order Process.

Commissioner Benavides moved to commence the negotiations with Bi-Tech and Hewlett-Packard/IBM to enter into a Contract for the purchasing and financing of a Financial, Human Resource, Work Order System, Budgeting, Grant Management and Job/Project, Ledger Accounting Program.

The motion was seconded by Commissioner Cascos and carried unanimously.

(8) ADOPTION OF A PROCLAMATION DESIGNATING APRIL 7, 1997, THROUGH APRIL 13, 1997, AS APUBLIC HEALTH WEEK® IN CAMERON COUNTY

(20) APPROVAL OF THE INTERLOCAL AGREEMENT BETWEEN CAMERON COUNTY AND THE SANTA ROSA INDEPENDENT SCHOOL DISTRICT, FOR THE SCRAPING OF THE TRACK AND ROLLING OF THE INFIELD OF THE BASEBALL FIELD

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Interlocal Agreement between Cameron County and the Santa Rosa Independent School District was approved, for the scraping of the track and the rolling of the infield of the Baseball Field.

(21) IN THE MATTER OF THE CAMERON COUNTY PRO BONO PROJECT TO UTILIZE THE GARCIA ROOM, 4TH FLOOR CAMERON COUNTY COURTHOUSE, ADMINISTRATIVE BUILDING, FOR OFFICE SPACE (TABLED)

At this time, Judge Hinojosa explained that the Texas Rural Legal Aide had cut back resources and were relocating their office to Harlingen, Texas, noting that there would not be a Legal Aide Office in Brownsville, Texas. He stated that the Cameron County Bar Association Pro Bono Project, in conjunction with the Texas Rural Legal Aide were housed in the Brownsville Office and added that they had requested to utilize any available space in the Courthouse, which was the Garcia Room. Judge Hinojosa expressed his support for said action, based on the valuable service that was provided to the community which allowed the Cameron County Bar Association to utilized attorneys at no cost to indigent individuals throughout the County.

Commissioner Peña stated that there were several issues regarding illegal subdivisions and questioned whether the legal services could be provided for the County and Judge Ben Neece, Municipal Court, responded that arrangements could be made between the Cameron County Bar Association Pro Bono Project and the County.

At this time, Judge Neece briefly highlighted the statistics of the Cameron County Pro Bono Project and explained why the Garcia Room was necessary.

Commissioner Peña expressed concern as to whether the Garcia Room had been previously requested by County employees and added that the County needs should be assessed before filling the available space.

Judge Hinojosa suggested that the Item be Tabled for one (1) week, in order to allow County employees to request the necessary office space.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, this Item was **(TABLED)** for one (1) week.

(22) APPROVAL OF THE PROPOSED FLOOR PLANS AND RENOVATIONS FOR THE CONSOLIDATION OF THE COUNTY OFFICES IN PORT ISABEL AT 313 QUEEN ISABELLA (HIGHWAY 100)

Commissioner Peña moved that the proposed floor plans and renovations for the consolidation of the County Offices in Port Isabel at 313 Queen Isabella (Highway 100), be approved.

The motion was seconded by Commissioner Benavides and carried as follows:

Commissioner Peña moved that the Lease Contract with Our Lady of Good Counsel Church for the building located at 1055 Military Highway, Brownsville, Cameron County, Texas, be approved for the Cameron County Health Department Women=s, Infants and Children Program.

The motion was seconded by Commissioner Benavides and carried unanimously.

Commissioner Peña moved that the Lapse Salaries and the Road and Bridge Fund be utilized to provide two

(2) Extra Help Positions to meet current demands on vehicle maintenance and provide a mechanic dedicated to the

Cameron County Park Project.

The motion was seconded by Commissioner Cascos and carried unanimously.

At this time, Ms. JuaNita Brodecky, Rio Hondo resident, expressed concern regarding the status and the cost of the Project.

Commissioner Cascos stated that Grant Funds, in the amount of \$450,000.00, were allocated for the hard costs and that the County was contributing the manpower and equipment, noting that the completion of the Project was anticipated for September or October, 1997. He stated that the costs of the manpower and equipment by the County were fixed costs and added that rural areas did not generate enough property taxes, in order to pay for the cost of repairing the roads.
