The meeting was called to order by Judge Pro-tem Carlos H. Cascos.

Upon motion by Commissioner Matz, seconded by Commissioner Benavides and carried unanimously, the

(2) EXECUTIVE SESSION

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the Court

met in Executive Session at 4:10 P.M. to discuss the following matters:

- a) Confer with County Counsel regarding the Professional Service Contract for the Rural Law Enforcement Satellite Offices; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.071 (2);
- b) Deliberation regarding the Real Property concerning the Right-of-Way acquisition of Parcel No. 6, for 77/83 Extension; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.072; and
- c) Deliberation regarding the Real Property known as Cameron County Trustee, Lot No. 7A and No. 7B, Block No. 4, Avondale Addition, City of Harlingen; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.072.

At this time, Judge Hinojosa asked Mr. Bob Clark, Brownsville resident for the invocation and Commissioner

Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the

Court reconvened in Regular Session at 5:10 P.M.

(3) ACTION RELATIVE TO EXECUTIVE SESSION

a) Confer with County Counsel regarding the Professional Service Contract for the Rural Law Enforcement Satellite Offices.

Judge Hinojosa reported that the Contract should be negotiated with the Architect, along the terms and

conditions as outlined in Executive Session regarding said matter.

Commissioner Cascos moved that the Professional Service Contract be negotiated with the Architect

regarding the Rural Law Enforcement Satellite Offices, along the terms and conditions as outlined in Executive

Session.

The motion was seconded by Commissioner Benavides and carried unanimously.

b) Deliberation regarding the Real Property concerning the Right-of-Way acquisition of Parcel No. 6, for 77/83 Extension.

Judge Hinojosa reported that the Right-of-Way Department should be directed to make an offer, along the

terms and conditions as outlined in Executive Session, regarding said matter.

c) Deliberation regarding the Real Property known as Cameron county Trustee, Lot No. 7A and No. 7B, Block No 4, Avondale Addition, City of Harlingen.

Judge Hinojosa reported that the foreclosure and sale of said property should be allowed, along the terms and condition as outlined in Executive Session.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the foreclosure and sale of the Real Property known as Cameron County Trustee, Lot No. 7A and No. 7B, Block No. 4, Avondale Addition, City of Harlingen, was authorized along the terms and conditions as outlined in Executive Session.

(4) APPROVAL OF COUNTY CLAIMS

At this time, Mr. Mark Yates, County Auditor, presented an additional late claim as to the County and District Clerks=Association, Warrant No. 36472, in the amount of \$880.00.

Upon motion by Commissioner Matz, seconded by Commissioner Peña and carried unanimously, the County Claims were approved as presented by the County Auditor, inclusive of the late claim as to Warrant No. 36472, in the amount of \$880.00.

The Budget Officer-s Comments Report is as follows:

(2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

Commissioner Cascos expressed concern regarding the Budget Amendment for the Vehicle Maintenance Position being currently allocated from the General Fund, as opposed to the Consolidated Road and Bridge Fund.

Mr. Mark Yates, County Auditor, stated that supervisory arrangements were being discussed, in order to place the position in the Engineering Department and added that the position was managed under the Fleet Maintenance Director, noting that the Budget and Management were allocated in two (2) different areas, which needed to be resolved.

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the following Salary Schedules were approved:

(7) PRESENTATION AND ACKNOWLEDGMENT OF THE INTERIM REPORT ON THE INVESTMENTS OF THE COUNTY FUNDS THROUGH MARCH 31, 1997

At this time, Mr. Eddie A. Gonzalez, County Treasurer, highlighted the Interim Report on the Investments of the County Funds as referenced in the Interest Earned for the Fiscal Year 1996/1997.

Mr. Mark Yates, County Auditor, stated that the remaining part of the Toll Bridge funds transfer had been

transferred to the General Fund, in order to increase the interest earned.

Mr. Gonzalez suggested that the slots be filled on the Investment Advisory Committee and stated that the

Committee should consist of a Banker, an Investment Banker, a private citizen with business background, a member of

the Court and the County Auditor=s Office.

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the

Presentation of the Interim Report on the Investments of the County Funds through March 31, 1997, was acknowledged.

The Report is as follows:

(8) ADOPTION OF A RESOLUTION ACKNOWLEDGING THE OPENING, ESTABLISHMENT, EXISTENCE AND THE SERVICE OF THE PORT ISABEL BRANCH TAX OFFICE LOCATED AT 313 QUEEN ISABELLA, PORT ISABEL, CAMERON COUNTY, TEXAS

Commissioner Cascos moved that the Resolution acknowledging the opening, establishment, existence and the

Service of the Port Isabel Branch Tax Office, located at 313 Queen Isabella, in Port Isabel, Cameron County, Texas, be

adopted.

The motion was seconded by Commissioner Peña and carried unanimously.

(9) ADOPTION OF A RESOLUTION SUPPORTING THE DENTISTS WHO CARE, INCORPORATED, MOBILE DENTAL UNIT PROGRAM

Upon motion by Commissioner Cascos, seconded by Commissioner Matz and carried unanimously, the

Resolution supporting the Dentists Who Care, Incorporated, Mobile Dental Unit Program, was adopted.

(10) ADOPTION OF A RESOLUTION DECLARING CAMERON COUNTY-S INTENT TO FUND A THIRD COUNTY COURT AT LAW WITHIN THE FISCAL YEAR 1999 BUDGET, TO BECOME EFFECTIVE NOT BEFORE JANUARY 1, 1999

Commissioner Cascos moved that the Resolution declaring Cameron County-s intent to fund a third County

Court at Law within the Fiscal Year 1999 Budget, to become effective not before January 1, 1999, be adopted.

The motion was seconded by Commissioner Matz and carried unanimously.

The Resolution is as follows:

(11) IN THE MATTER OF THE ISSUANCE OF AN ORDER TO THE LAW FIRM OF HEARD, GOGGAN, BLAIR AND WILLIAMS TO CEASE FURTHER FILING OF DELINQUENT TAX LAWSUITS (TABLED)

Judge Hinojosa moved that this Item be TABLED.

The motion was seconded by Commissioner Cascos.

At this time, Mr. Tony Yzaguirre, Tax Assessor-Collector, reported that fifty (51) businesses had been closed,

due to the law suites filed by the Firm of Heard, Goggan, Blair and Williams and noted that the required backup

documentation had not been submitted to the County, which was part of the Contract. He stated that the Firm of

Calame, Linebarger, Graham and Peña confirmed that they submitted reports and documentation regarding each law

suit filed as required by the terms of the Contract.

Judge Hinojosa stated that he had received assurances that there would be no additional law suits filed and

stated that he had accepted the verbal assurances, noting that the District Clerk would follow up on said issue.

Upon motion duly made by Judge Hinojosa, seconded by Commissioner Cascos and carried unanimously, this

Item was **TABLED**.

(12) AUTHORIZATION TO RENEW THE LEASE AGREEMENT FOR AN ADDITIONAL ONE YEAR CONTRACT WITH OAK CREST MANAGEMENT, DOING AS BUSINESS AS BROWNSVILLE BUSINESS PARK JT. VT. NO. 1, WAREHOUSE BUILDING LOCATED AT 3547 EAST 14TH STREET, SUITE AM@, BROWNSVILLE, TEXAS

Commissioner Peña moved that the Lease Agreement be renewed for an additional one (1) year Contract with Oak Crest Management, doing business as Brownsville Business Park JT. VT. No. 1, Warehouse Building, located at

3547 East 14th Street, Suite AM@, Brownsville, Texas.

The motion was seconded by Commissioner Benavides and carried unanimously.

At this time, Judge Hinojosa stated that several machines had been moved out of the warehouse and questioned whether the available space would be utilized and Mr. Remi Garza, Executive Assistant to the County

Judge, responded that the Elections Department had requested to utilize the space during the Elections.

Ms. Yolanda de Leon, District Attorney, stated that the District Attorney-s Office had been contracting out for

additional storage space and added that any available County space would provide the District Attorney-s Office with

the needed storage space.

Judge Hinojosa suggested that this Item be Tabled, in order to further examine the available space before making a commitment in leasing additional space.

Mr. Joseph Ardito, Property Management Coordinator, noted that the Lease had terminated May 31, 1997, and added that the rent would increase from the amount of \$761.00 to \$,1,200.00 per month, if the Lease Agreement was held any longer.

Mr. Mark Yates, County Auditor, recommended that the Bids should be advertised for the machines which were transferred out of the warehouse.

Upon motion duly made by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Lease Agreement was renewed for an additional one (1) year Contract with Oak Crest Management, doing business as Brownsville Business Park Jt. Vt. No. 1, Warehouse building, located at 3547 East 14 Street, Suite AM[®], Brownsville, Texas.
