The meeting was called to order by Judge Pro-tem Carlos H. Cascos.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on July 25, 1997, at 9:36 A.M.:

(1) AUTHORIZATION TO OPEN THE REQUEST FOR PROPOSAL NO. 97-07-04 FOR CONSTRUCTION MANAGEMENT SERVICES FOR THE SOUTH TEXAS BOOT CAMP

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Request for Proposal No. 97-07-04 for the Construction Management Services for the South Texas Boot Camp was opened.

The Request for Proposals received and opened are as follow:

(2) EXECUTIVE SESSION

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Court met in Executive Session at 4:10 P.M. to discuss the following matters:

- a) Confer with County Counsel concerning the settlement negotiations with Pottery S, involving the Dancy Building, pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.071 (1)(B);
- b) Confer with County Counsel concerning the potential litigation regarding the Dancy Building; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.071 (1)(A and B);
- c) Confer with County Counsel on the litigation of the acquisition of Parcel No. 7, 1997-CCL-570-B and Parcel No. 4, 1997-CCL-517-A, Nurith Galonsky, Tally Galonsky, and Israel Lizka, owners; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.071 (1)(B);
- d) Deliberation regarding the Real Property concerning the Right-of-Way acquisition of Parcel No. 1 for Highway 77/83 extension and Parcel No. 8, East Loop; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.072; and
- e) Confer with County Counsel regarding the Professional Service Contract for the Rural Law Enforcement Satellite Offices; pursuant to Vernon Texas Code Annotated (V.T.C.A.), Government Code, Section 551.071 (2).

At this time, Judge Hinojosa asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the Court reconvened in Regular Session at 5:10 P.M.

(3) ACTION RELATIVE TO EXECUTIVE SESSION

a) Confer with County Counsel concerning the settlement negotiations with Pottery S, involving the Dancy Building.

Mr. Doug Wright, Cameron County Counsel, reported that the Contractual Agreement should be authorized as per the settlement with regard to the terra-cotta.

Upon motion by Commissioner Cascos, seconded by Commissioner Peña and carried unanimously, the Contractual Agreement with Pottery S was approved, as per the settlement with regard to the terra-cotta concerning the Dancy Building.

b) Confer with County Counsel concerning the potential litigation regarding the Dancy Building.

Commissioner Cascos reported that the Status Report by County Counsel should be acknowledged regarding the potential litigation regarding the Dancy Building.

Commissioner Cascos moved that the Status Report by County Counsel be acknowledged regarding the potential litigation concerning the Dancy Building.

The motion was seconded by Commissioner Benavides and carried unanimously.

c) Confer with County Counsel on the litigation of the acquisition of Parcel No. 7, 1997-CCL-570-B and Parcel No. 4, 1997-CCL-517-A, Nurith Galonsky, Tally Galonsky and Israel Linka, owners.

Commissioner Cascos reported that the amount of \$10,096.00, regarding Parcel No. 7, and that the amount of \$100,534.00, regarding Parcel No. 4, should be deposited into the Registry of the Court, noting that the payments related to said Parcels should be approved regarding Court Costs, Court Reporter Fees, and the Special Commissioners=Fees.

Commissioner Cascos moved that the amount of \$10,096.00, regarding Parcel No. 7, 1997-CCL-570-B, and the amount of \$100,534.00, regarding Parcel No. 4, 1997-CCL-517-A, Nurith Galonsky, Tally Galonsky and Israel Linka, owners, be deposited into the Registry of the Court, and that the payments regarding the Court Costs, Court Reporters=Fees and the Special Commissioners Fees be approved.

(7) PRESENTATION ON THE VALLE HERMOSO/VALLE ESCONDIDO WASTEWATER TREATMENT PLANT

At this time, Mr. Juan Bernal, County Engineer, introduced Mr. Ernesto Hinojosa, Assistant County Engineer, and Ms. Angie Cavazos, Texas Water Development Board.

Mr. Sam Angori, Texas Water Development Board, highlighted and explained the status and progress of the Valle Hermoso and Valle Escondido Wastewater Treatment Plant.

Commissioner Cascos expressed concerns as to the Drainage Project and the construction of the Waste Water Treatment Plant and whether said Project would resolve the flooding issues.

There was some discussion regarding the cost and negotiations and Judge Hinojosa clarified the roles and funding of the County and the Project Engineers regarding the Interlocal Agreement.

Judge Hinojosa requested that the Project design be submitted to the Texas Water Development Board within sixty (60) days for approval, in order to begin construction.

Commissioner Benavides moved that the Presentation on the Valle Hermoso and the Valle Escondido Wastewater Treatment Plant be acknowledged.

The motion was seconded by Peña and carried unanimously.

(8) AUTHORIZATION OF THE REQUESTED REMODELING OF THE WORK AREA FOR THE COURT ADMINISTRATOR FOR THE MASTER COURT

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the remodeling of the work area for the Court Administrator for the Master Court was approved, said funding to be allocated from the next Budget cycle.

(9) APPROVAL OF TAX REFUNDS

Commissioner Peña moved that the following Tax Refunds be approved:

- a) Carmela Celaya, in the amount of \$790.15 Religious Exemption;
- b) Texas Commerce Bank, in the amount of \$13,735.73 Court Judgement No. 95-08-3792-C; and
- c) Textron Financial Corporation, in the amount of \$ 2,387.33 Double Assessed.

The motion was seconded by Commissioner Cascos and carried unanimously.

(10) AUTHORIZATION TO ISSUE PERMIT NO. 17 TO JOSEPH P. NALLEY, DOING BUSINESS AS, AUTO CLINIC FOR BEACH TOWING SERVICES

Upon motion by Commissioner Benavides, seconded by Commissioner Cascos and carried unanimously, Permit No. 17 was issued to Joseph P. Nalley, doing business as, Auto Clinic for Beach Towing Services.

(11) AUTHORIZATION TO ADVERTISE REQUEST FOR PROPOSALS FOR ARCHITECTURAL AND ENGINEERING SERVICES FOR THE BOCA CHICA PARK AND WILDLIFE REFUGE VISITOR-S CENTER AND ASSOCIATED IMPROVEMENTS

At this time, Mr. Kenneth Conway, Parks System Director, stated that the amount of \$500,000.00, was available in Bond Proceeds for the Project, which would initiate the Architects plan for the design of the proposed Visitors Center and suggested that a qualified individual be retained to assist the architect.

Commissioner Cascos expressed concern as to the Texas Parks and Wildlife Departments participation in the Project regarding the four thousand (4,000) acres of land to be donated and whether funds would be requested from said entity for the Project.

Mr. Conway stated that the Bonds were identified for the Parks System at the time the bonds were sold and clarified that the Texas Parks and Wildlife would be releasing over one thousand (1,000) acres and that the United States Fish and Wildlife would also be donating land to the County.

Commissioner Cascos explained that the available Bond Proceeds were allocated from the proposed Port of Brownsville Park Project and expressed concern as to where the funds would be derived from, if the Bond Proceeds did not exist.

Judge Hinojosa responded that additional Bonds would need to be issued and that the County did not want to request additional grant funds from the Texas Parks and Wildlife Department. He stated that many Projects existed, due to the generosity and close relationship to the County with the Texas Parks and Wildlife Department.

At this time, Mr. Francisco Sinfuentes expressed his concerns regarding the deteriorated conditions of the Boca Chica Beach and suggested that a Committee should be formed consisting of members from the community, in order to provide County residents a safe and clean affordable park.

Commissioner Benavides expressed his concern regarding the problems that existed at the Park and stated that a price would have to be paid, in order to maintain a clean and secured environment.

Commissioner Benavides moved that Request for Proposals be advertised for Architectural and Engineering Services for the Boca Chica Park and Wildlife Refuge Visitors Center and that the associated improvements be approved.

The motion was seconded by Commissioner Cascos and carried unanimously.

At this time, Mr. Conway stated that the proposed Visitors Center would be built by June, 1998, noting that the design was a sixty (60) day process and that the construction would begin in approximately six (6) months.

(12) APPROVAL TO PURCHASE APPROXIMATELY \$22,000.00 OF COMPUTER EQUIPMENT FOR THE UNIFIED NARCOTICS INTELLIGENCE TASK-FORCE FROM THE COMPUTER EDUCATION SOLUTION

Upon motion by commissioner Cascos, seconded by Commissioner Peña and carried unanimously, the purchase of approximately \$22,000.00 of computer equipment for the Unified Narcotics Intelligence Task-Force from the Computer Education Solution was approved.

(13)ADOPTION OF A RESOLUTION FOR THE PARTICIPATION IN STATE PURCHASING CONTRACTS AND STATE CATALOG PURCHASING WITH THE GENERAL SERVICES **COMMISSION FOR FISCAL YEAR 1997-1998** AND **AUTHORIZATION** TO **CONTINUE PARTICIPATION** IN HOUSTON/GALVESTON AREA COUNCIL OF GOVERNMENTS PURCHASING INTERLOCAL AGREEMENT

Upon motion by Commissioner Peña, seconded by Commissioner Cascos and carried unanimously, the Resolution was adopted, for the participation in State Purchasing Contracts and State Catalog purchasing with the

General Services Commission for Fiscal Year 1997-1998, and for the continued participation in the Houston/Galveston Area Council of Governments Purchasing Interlocal Agreement.
