The meeting was called to order by Judge Gilberto Hinojosa. He then lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on October 10, 1997, at 10:26 A.M.:

### (1) APPROVAL OF COUNTY CLAIMS

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the County Claims were approved as presented by the County Auditor.

### (2) APPROVAL OF BUDGET AMENDMENTS AND/OR SALARY SCHEDULES

At this time, Ms. Mary Lou MacNelly, Assistant Auditor, presented the Annual Salary Schedules for the General Fund and the Road and Bridge Fund.

Commissioner Cascos questioned whether the Salary Schedules had been reviewed, in order to determine whether any slots received more or less than the four percent (4%) salary increases and Ms. MacNelly responded that there were changes in job descriptions due to evaluations performed the previous year.

Commissioner Matz questioned how the results of the Salary Grievance Meeting were handled in relation to the Salary Schedules and Ms. MacNelly responded that the changes in the Elected Officials=salaries were incorporated into the General Fund Salary Schedules.

At this time, Mr. Doug Wright, Commissioners=Court Legal Counsel, noted that there was no action to be taken by the Court for the nine (9) to zero (0) votes of the Salary Grievance Committee and added that the Committee had the latitude to award an amount above the requested amount.

Commissioner Matz clarified that the Salary Schedule for the Road and Bridge Fund should be corrected to reflect the Administrative Assistant at a full-time slot and the Secretary Position at a half-time slot for Precinct No. 3.

Judge Hinojosa stated that a salary base should be defined for the vacant Secretary Position in the Road and Bridge Salary Schedule before the slot was filled, in order to begin the equalization among the slots.

Commissioner Cascos stated that due to the consolidation of Precincts No. 1 and No. 2, only one (1) secretary might be needed for the both Precincts.

Commissioner Benavides stated that Precinct No. 1 was overwhelmed with incoming phone calls and noted that the second Secretary Position was necessary for back up in the absence of either slot.

Judge Hinojosa suggested that the position be available for future needs and stated that once there was a vacancy in a Secretarial Slot, the issue would be brought before the Court, in order to set a base salary.

Commissioner Peña moved that the Salary Schedules be approved.

The motion was seconded by Commissioner Cascos and carried unanimously.

The Salary Schedules are as follow:

### (3) APPROVAL OF THE MINUTES OF SEPTEMBER 23, 1997, AND SEPTEMBER 30, 1997

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the Minutes of the Regular Meeting held September 23, 1997, at 9:30 A.M., and the Regular Meeting held September 30, 1997, at 9:30 A.M., were approved.

# (4) IN THE MATTER A CONSTRUCTION MANAGEMENT SERVICE AGREEMENT FOR THE SOUTH TEXAS BOOT CAMP FACILITY WITH PEACOCK CONSTRUCTION (TABLED)

At this time, Commissioner Matz suggested that this Item be Tabled until additional information was submitted.

Commissioner Peña noted that there were programmatic aspects of the program which needed to be reviewed and suggested the Item be Tabled for thirty (30) days.

Judge Hinojosa stated that the funds from the Lapsed Salaries, the start up costs and the funds set aside in the County-s Budget was close to the Budget necessary for the Boot Camp Project and expressed concern as to the necessity for the delay.

Commissioner Peña questioned who would be controlling the Programs and Judge Hinojosa responded that the slot for a Director of the Boot Camp Committee had been created, noting that said issue would be performed inhouse, as opposed to contracting an outside agency.

Commissioner Matz moved that this Item be **TABLED** for thirty (30) days.

The motion was seconded by Commissioner Peña and carried as follows:

At this time, Mr. Juan Bernal, County Engineer, expressed his gratitude for the work and efforts of the County employees who assisted during the heavy rains and flooding of Cameron County.

Commissioner Benavides suggested that an Agenda Item concerning the status of the Valle Escondido Project be placed on the Agenda for the next Meeting.

Judge Hinojosa stated that the Road and Bridge Public Works Department employees worked above and beyond their call of duty during the heavy rains and floods, in order to ensure the safety of the residents of the County.

Commissioner Cascos noted that Mr. Albert Naranjo and Mr. Bud Wentz, County residents, volunteered their tractors and pumps to drain out the water in the Olmito area.

Commissioner Matz commended Mr. Desi Najera, Emergency Management Coordinator, for his prompt attention to the situation.

The motion was seconded by Commissioner Peña and carried unanimously.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Contract between the Cameron County Juvenile Probation Department and Dr. Xavier AJay@ Martinez, Practicing Psychologist, was approved to provide Psychological evaluations for Cameron County Juveniles as ordered by the Courts.

- (8) APPROVAL OF THE CONTRACT BETWEEN CAMERON COUNTY AND THE BROWNSVILLE INDEPENDENT SCHOOL DISTRICT TO JOIN TOGETHER AND PROVIDE A JUVENILE PROBATION OFFICER TO WORK WITH STUDENTS ATTENDING THE BISD AT THE ALTERNATIVE SCHOOLS
- (9) APPROVAL OF THE CONTRACT BETWEEN CAMERON COUNTY AND THE SAN BENITO INDEPENDENT SCHOOL DISTRICT TO JOIN TOGETHER AND PROVIDE A JUVENILE PROBATION OFFICER TO WORK WITH STUDENTS ATTENDING THE SBISD AT THE ALTERNATIVE SCHOOLS

The motion was seconded by Commissioner Benavides and carried unanimously.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Contracts for Providers of Residential Child Care Services for the Cameron County Juvenile Probation Department Fiscal Year 1997-1998, was approved.

## (12) AUTHORIZATION TO ADVERTISE FOR BIDS ON THE SALE OF VOTING MACHINES (SHOUP MACHINES)

At this time, Judge Hinojosa clarified that the sale of the Voting Machines would be to any entity, except a political entity in the County for purposes of elections, noting that the political entities could buy the machines strictly for school elections.

Commissioner Peña moved that the Bids be advertised for the sale of Voting Machines (Shoup Machines).

The motion was seconded by Commissioner Benavides and carried unanimously.

PUBLIC HEARING TO DISCUSS THE PROPOSED BOUNDARY ADJUSTMENTS ON THE VOTING TABULATION DISTRICTS NOS. 23 AND 25 FROM THE JUSTICES OF THE PEACE PRECINCTS NOS. 3 AND 7, PURSUANT TO VERNON-S ANNOTATED TEXAS CONSTITUTION ARTICLE 5, SECTION 18, AND SUBCHAPTER B, SECTION 42.0321 AND SECTION 42.032.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, the Public Hearing was opened to discuss the proposed boundary adjustments on the Voting Tabulation Districts (VTD=s) No. 23 and No. 25 from Justices of the Peace Precincts No. 3 and No. 7, pursuant to Vernon=s Annotated Texas Constitution Article No. 5, Section 18, and Subchapter B, Section 42.0321 and Section 42.032.

At this time, Judge Hinojosa explained that boundary adjustments needed to be corrected from an omission of a Precinct that occurred as a result of the redistricting.

Hearing and sensing no further comments, upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the Public Hearing was closed.

(14) ADOPTION OF A COMMISSIONERS= COURT ORDER RESOLUTION TO ADJUST THE BOUNDARIES ON VOTING TABULATION DISTRICTS NOS. 23 AND 25, JUSTICES OF THE PEACE PRECINCTS NOS. 3 AND 7, PURSUANT TO VERNON-S ANNOTATED TEXAS CONSTITUTION, ARTICLE NO. 5, SECTION 18 AND SUBCHAPTER B, SECTION 42.0321 AND SECTION 42.032

Upon motion by Commissioner Benavides, seconded by Commissioner Peña and carried unanimously, the Commissioners= Court Order Resolution was adopted, adjusting the boundaries on the Voting Tabulation Districts (VTD=s) No. 23 and No. 25 Justices of the Peace Precincts No. 3 and No. 7, pursuant to Vernon=s Annotated Texas Constitution, Article No. 5, Section 18, and Subchapter B, Section 42.0321 and Section 42.032.

At this time, Commissioner Matz requested that a list of the current members and the designators be provided by the Executive Assistant to the County Judge.

Upon motion by Commissioner Peña, seconded by Commissioner Benavides and carried unanimously, Ms. Sandra Zamora was appointed to the Cameron County Dune Protection Committee.

(16) AUTHORIZATION TO REJECT ALL BIDS RECEIVED FOR THE 1996 DISASTER RELIEF GRANT PROJECT (ROAD REPAIRS) TEXAS COMMUNITY DEVELOPMENT PROJECT (TCDP) CONTRACT NO. 716097 AND AUTHORIZATION FOR THE PROJECT ENGINEER TO READVERTISE AND REBID THE PROJECT

Commissioner Peña moved that the Bids received for the 1996 Disaster Relief Grant Project (Road repairs)

Texas Community Development Project (TCDP) Contract No. 716097 be rejected and that the Project Engineer be authorized to readvertise and rebid the Project.

The motion was seconded by Commissioner Cascos and carried unanimously.

(17) AUTHORIZATION TO AWARD THE BID TO DONALD D. FERGUSON, INCORPORATED, FOR THE CONSTRUCTION OF THE COUNTY COURT BUILDING SOUTH EAST PARKING LOT

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the Bid was awarded to Donald D. Ferguson, Incorporated, for the construction of the County Court Building South East Parking Lot.

(18) AUTHORIZATION FOR THE PUBLIC WORKS DEPARTMENT TO DO ROAD REPAIR WORK ON A PRIVATE ROAD (NOGALES RANCH ROAD)

At this time, Commissioner Cascos expressed concern as to the work that was to be performed since the road was a Private Road.

Mr. Juan Bernal, County Engineer, stated that the County would perform the maintenance of the road and would bring the road to its original state.

Ms. Rita P. Taylor, Brownsville resident, suggested that the road should be researched due to the land being owned by a different individual which might have made the road a County Road.

Commissioner Cascos moved that the Public Works Department be authorized to perform road repair work on a Private Road (Nogales Ranch Road).

The motion was seconded by Commissioner Matz and carried unanimously.

(19) APPROVAL TO TEMPORARILY BLOCK TRAFFIC ON OCTOBER 31, 1997, AT THE NUECES PARK LANE SUBDIVISION - TRANSPORTATION CODE 251.158

Commissioner Matz moved that the traffic be temporarily blocked on October 31, 1997, at the Nueces Park Lane Subdivision, as per Transportation Code 251.158.
