(1) **JUDGE DAVID WISE, JUSTICE OF THE PEACE,  
PRECINCT NO. 5, PLACE NO. 2**

At this time, Judge David Wise, Justice of the Peace, Precinct No. 5, Place No. 2, requested an auto allowance increase, in the amount of \$600.00 and briefly highlighted the number of duties performed by the Justice of the Peace which required him to travel.

Judge Hinojosa expressed his support concerning the request for the increased auto allowance by Judge Wise, but noted that increasing the auto allowance would skew the intent to equalize the Justice-s of the Peace salaries Countywide.

Ms. Mary Salinas moved that the auto allowance for Judge David Wise, Justice of the Peace, Precinct No. 5, Place No. 2, be increased by the amount of \$600.00.

The motion was seconded by Ms. Edna Santoscoy.

The motion failed by a five (5) to four (4) vote.
