# (6) DISCUSSION OF SECURITY ISSUE PERTAINING TO THE COUNTY COURTHOUSE PARKING LOTS

At this time, Mr. Remi Garza, Executive Assistant to the County Judge, stated that a Memorandum had been received from County Court at Law No. 2 concerning Staff=s and Juror=s vehicles being burglarized at the Courthouse parking lot. He advised the Court that the matter had been discussed in Court in 1997, but noted that no action had been taken at the time. Mr. Garza explained that the Court had discussed hiring a Deputy to secure the Courthouse parking lots, but noted that there were concerns as to the jurisdiction of the parking lots.

Commissioner Cascos stated that discussions had been held regarding the fencing of the parking lots and as to the number of deputies necessary to secure the parking lots.

At this time, Sheriff Omar Lucio, County Sheriff, stated that the matter be deferred for one week, in order to

review the issue and present a recommendation to the Court.

He stated that the Constables had participated in the program for the past five (5) years and added that the Mexican Law Enforcement should be encouraged to participate in educational County Programs.

Judge Hinojosa expressed his support for the Constables=participation in the education process with Mexico and commended the Constables for their time and efforts to represent Cameron County.

Commissioner Matz suggested that the Constables should participate and emphasize the joint project concerning seat belt laws and regulations implemented by the Department of Public Safety and Mexico.
