ABSENT:

The meeting was called to order by Judge Gilberto Hinojosa at 10:20 A.M. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on September 22, 2000, at 1:45 P.M., and the Supplemental Agenda posted on September 22, 2000, at 1:43 P.M.:

(11) APPROVAL OF RENEWAL OF THE PAYMENT PROCESSING AGREEMENT BETWEEN THE OFFICE OF THE ATTORNEY GENERAL AND THE CAMERON COUNTY DISTRICT CLERK-S OFFICE - CHILD SUPPORT DIVISION (CONTRACT NO. 01-01481) FOR THE REIMBURSEMENT OF CHILD SUPPORT PAYMENT PROCESS

Upon motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the Renewal Payment Processing Agreement between the Office of the Attorney General and the Cameron County District Clerk-s Office - Child Support Division (Contract No. 01-01481) for the reimbursement of Child Support Payment Process was approved.

The Agreement is as follows:

At this time, Mr. Dick Sturgell, Harlingen resident, expressed concern as to the vehicles with political advertisements parked in the Courthouse Parking Lot and as to the solicitation by carwash vendors in the parking lots.

Commissioner Cascos noted that there had been an issue regarding vehicles with political signs parked in the handicapped parking areas and stated that it was unknown as to whether there was a policy limiting the time parked in the designated areas.

Mr. Doug Wright, Commissioners= Court Legal Counsel, stated that the Court could regulate the use of the County Parking Lot and added that the parking lot was a constitutional protected area, noting that the Court should take precaution as to the regulations.

Commissioner Benavides expressed his support as to the parking of vehicles with political advertisements, based on the AFreedom of Expression® and added that the Courthouse parking lot was a Apeoples= parking lot.®

There was some discussion as to safety and liability issues during voting times and Legal Counsel was directed to review the matter and to place the issue on the Agenda.

At this time, Mr. Mark Yates, presented additional late claims as to Warrants No. 42900 through No. 42908 and noted that the payee on Warrant No. 42698 should reflect Francis M. Gumbel, M.D.

Commissioner Valencia moved that the County Claims be approved, as presented by the County Auditor, inclusive of the late claims as to Warrant Nos. 42900 through 42908.

The motion was seconded by Commissioner Matz and carried as follows:

Commissioner Cascos moved that the 2000 Fiscal Year Budget Amendment No. 2000-45, be approved.

The motion was seconded by Commissioner Matz and carried unanimously.

The Budget Amendments are as follow:

(3) APPROVAL OF MINUTES OF SEPTEMBER 12, 2000, REGULAR MEETING

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the Minutes of the Regular Meeting held September 12, 2000, at 9:30 A.M., were approved, subject to the correction noted on Item No. 6, Page No. 4.



(4) APPROVAL OF THE LICENSE AGREEMENT BETWEEN CAMERON COUNTY AND THE TOWN OF SOUTH PADRE ISLAND REGARDING THE TEMPORARY PLACEMENT OF A DREDGE PIPELINE THROUGH ISLA BLANCA PARK

Commissioner Matz moved that the License Agreement between Cameron County and the Town of South Padre Island regarding the temporary placement of a dredge pipeline through Isla Blanca Park be approved.

The motion was seconded by Commissioner Valencia and carried unanimously.

The Agreement is as follows:

**(5) ACTION ON RECOMMENDATIONS OF
CAMERON COUNTY SALARY GRIEVANCE
COMMITTEE**

At this time, Judge Hinojosa reported that fourteen (14) Elected Officials had not grieved the set salaries and that there was an unappropriated amount of \$12,110.00, which was budgeted with the across the board cost of living increase. He stated that the Salary Grievance Committee had voted unanimously for the majority of the Elected Officials= Salary grievances with the exception of Justice of the Peace Oscar Tullos, Precinct No. 2, Place No. 2, noting that the vote for Judge Tullos was 8 to 1. Judge Hinojosa stated that increasing the salary for Judge Tullos would place him at the same level as the Justice of the Peace Tony Torres, Precinct No. 2, Place No. 1 and added that the workload and collections were higher in Judge Tullos= office than all the Justices of the Peace in the County.

Commissioner Valencia moved that the Salary Grievance request by Justice of the Peace Precinct No. 2, Place No. 2, to increase the salary to \$37,865.00, be approved.

The motion was seconded by Commissioner Benavides and carried as follows:

Commissioner Cascos moved that the recommendations of the Cameron County Salary Grievance Committee be accepted.

**(6) PRESENTATION BY MR. KAMAL ARISS
REGARDING STATUS OF COUNTY JAIL
PROJECT**

At this time, Mr. Kamal Ariss, Landmark Organization, stated that the Jail Project was progressing quickly, due to good weather conditions and reported that the underground work for the Sheriff's Facility, including the electrical and plumbing was currently being performed. He added that Aselect fill® was being installed for the Jail Facility and that the underground work would begin in the next week. Mr. Ariss stated that schedules would be distributed every two weeks to keep the Court informed of the project status.

There was some discussion regarding semi-weekly meetings held to discuss the project status and the suggestion was made for Mr. Ariss to present the project status every second Tuesday of the month.

Mr. Ariss reported that the Sheriff's Office and County Engineer's Office met at the project site every two weeks and that the occupancy date was set for January 1, 2002.

Upon motion by Commissioner Benavides, seconded by Commissioner Valencia and carried unanimously, the Presentation by Mr. Kamal Ariss, Landmark Organization, regarding the status of the County Jail Project was acknowledged.

**(7) POSSIBLE AUTHORIZATION TO GIVE NOTICE
TO PROCEED WITH THE REMAINDER OF THE
CONSTRUCTION PHASE OF THE COUNTY JAIL
PROJECT TO LANDMARK ORGANIZATION, L.P.**

Commissioner Valencia moved that the Notice to Proceed with the remainder of the Construction Phase of the County Jail Project be given to Landmark Organization, L.P.

The motion was seconded by Commissioner Cascos and carried as follows:

(8) APPROVAL OF THE MEMORANDUM OF UNDERSTANDING RELATING TO THE INTEGRATION PROGRAM BETWEEN CAMERON COUNTY AND THE TEXAS DEPARTMENT OF TRANSPORTATION ALONG WITH NUMEROUS GOVERNMENTAL ENTITIES

At this time, Mr. Pete Sepulveda, Jr., Bridge Systems Director, stated that the Memorandum of Understanding would allow the County to participate in the development of a Regional Intelligence Transportation System. He noted that the County would not have to commit financial contributions, but added that County Staff would be assigned to work with the Texas Department of Transportation (TxDOT) and other entities.

Judge Hinojosa expressed concern regarding the status of the study of traffic congestion at Schlitterbahn Waterpark at South Padre Island and requested that a Status Report be presented to the Court, in order to meet the March 2001, opening date.

Commissioner Matz noted that as per Mr. Amadeo Saenz, Texas Department of Transportation, TxDOT had Plan A and Plan B and that Plan A would be executed by placing signals at the intersection, noting that Plan B consisted of more extensive work.

Commissioner Matz moved that the Memorandum of Understanding relating to the Integration Program between Cameron County and the Texas Department of Transportation along with numerous governmental entities be approved.

The motion was seconded by Commissioner Benavides and carried unanimously.

The Agreement is as follows:

(9) APPROVAL OF AGREEMENT BETWEEN CAMERON COUNTY, THE CITIES OF HARLINGEN AND SAN BENITO AND THE STATE OF TAMAULIPAS FOR THE PROMOTION OF THE FREE TRADE BRIDGE AT LOS INDIOS

Upon motion by Commissioner Matz, seconded by Commissioner Valencia and carried unanimously, the Agreement between Cameron County, the Cities of Harlingen and San Benito and the State of Tamaulipas for the promotion of the Free Trade Bridge at Los Indios was approved.

The Agreement is as follows:

Commissioner Benavides moved that the Strip Map, Parcel Sketches, Metes and Bounds Descriptions, Environmental Assessment, Appraisals, Title Commitments and Acquisitions of Right-of-Way for Old Alice Road be updated.

The motion was seconded by Commissioner Valencia and carried unanimously.



(12) **APPROVAL OF CHANGE ORDER NO. 3 TO THE CONSTRUCTION CONTRACT WITH CUBCO CONSTRUCTION, INCORPORATED, FOR THE LAGUNA MADRE AFFORDABLE HOUSING INITIATIVE (TCDP CONTRACT NO. 718118)**

Commissioner Benavides moved that Change Order No. 3 to the Construction Contract with Cubco Construction, Incorporated, be approved for the Laguna Madre Affordable Housing Initiative, that being the Texas Community Development Program Contract No. 718118.

The motion was seconded by Commissioner Matz and carried unanimously.

At this time, Judge Hinojosa questioned the status of the Empowerment Zone Project concerning Laguna Heights.

Mr. Frank Bejarano, Program Development and Management Director, stated that the Empowerment Zone had met early in the month to discuss the status of the project and added that Mr. Orlando Cruz, Project Engineer, had been instructed to continue the issue of reversing the flow of the drainage effluent. He added that the Project Engineer was waiting for the study being conducted by the Army Core of Engineers, but noted that a deadline had not been given.

Judge Hinojosa questioned the status of the El Norte Subdivision and Mr. Bejarano responded that El Norte Subdivision had been presented to the Empowerment Sub-Zone Committee and would be recommended for approval to the Rio Grande Valley Empowerment Zone.

At this time, Commissioner Matz expressed concern as to Item No. 19, regarding the Purchases without Purchase Orders for the Health Department.

Ms. Maria San Pedro, Director of Nurses, explained that the purchases which were for oxygen tanks, had been on a Contract and was changed to a month-to-month basis, but noted that the vendor had not been forwarding the invoices.

Mr. Mark Yates, County Auditor, suggested that the purchases without purchase orders be reviewed by Mr. Mike Forbes, Purchasing Agent, before being presented to the Court.

Judge Hinojosa stated that the County was spending a large amount of funds for Continuing Education for the County Law Enforcement Personnel and suggested that the County, together with Hidalgo County and the Cities, should sponsor the Continuing Education locally. He stated that the Law Enforcement Personnel should only attend training out

of the County, if the training was not offered locally and suggested that the Personnel Department schedule a meeting with the Constables- Office, the Sheriff-s Department and the District Judges to discuss the matter.

Mr. Manuel Villarreal, Personnel/Safety Risk Director, stated that the Personnel Department had initiated the process to consolidate all the County Law Enforcement Personnel and noted that Mr. Ronnie Saenz, Law Enforcement Safety Officer, had submitted the paperwork to receive credit from TCLEOSE to begin the process.

Judge Hinojosa recommended that all County Law Enforcement Personnel be informed in writing that all Continuing Education Programs to maintain the TCLEOSE Certification would be performed in Cameron County under a program approved by the State and added that justification by the Law Enforcement Personnel concerning specialized training not offered within the County, would be addressed by the Court.

Mr. Ronnie Saenz, Law Enforcement Safety Officer, stated that the Continuing Education Programs were offered locally, but noted that the Departments elected to attend the Programs out of the County.

Judge Hinojosa stated that there was over 600 Law Enforcement Personnel in the County and Cities and added that one (1) individual should perform the training, in order to achieve savings in the travel budgets.
