ABSENT:

The meeting was called to order by Judge Gilberto Hinojosa at 9:35 A.M. He then asked Mr. Bob Clark, Brownsville resident, for the invocation and Commissioner Cascos to lead the Court and the audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on October 6, 2000, at 3:43 P.M.:

(1) APPROVAL OF COUNTY CLAIMS

Commissioner Cascos moved that the County Claims be approved, as presented by the County Auditor.

The motion was seconded by Commissioner Benavides and carried as follows:

ABSTAINED: Judge Hinojosa, as to Warrant No. 43422, payable to Laguna Madre Water District, in the amount of \$151.66.

The Affidavit is as follows:

(2) **IN THE MATTER OF THE BUDGET
AMENDMENTS AND/OR SALARY SCHEDULES
(TABLED)**

At this time, Mr. Xavier Villarreal, Budget Officer, stated that the Bids for the printing of ballots had been received at a lower price than expected and that the Elections Administrator had requested that the available funds, in the amount of \$5,000.00 be allocated to upgrade salaries. Mr. Villarreal recommended that the funds not be distributed among salaries, based on a Memorandum submitted by the Elections Administrator concerning an anticipated shortfall.

Commissioner Cascos expressed his opposition as to the matter and added that other Departments would be requesting the same increases, if the Court approved the increases in the Elections Department.

Commissioner Benavides stated that the Elections Administrator had requested employee salary increases, but that the Court had never approved the increases. He stated the matter should be considered, based on the importance of the upcoming Election and expressed his support.

Mr. Robert Mendoza, Elections Administrator, explained that he was attempting to upgrade the salaries, based on the job descriptions and duties and added that the salaries were being adjusted to fit the experience, education and skills.

Commissioner Valencia stated that the upcoming Election was very important and expressed his support, in order to avoid any personnel problems during Election time.

Mr. Mendoza noted that the Elections Department had a new vendor for the ballots and that the funds were available to increase the salaries, due to the savings in the ballots.

Commissioner Matz stated that most of the County Departments were faced with the same salary issues and noted that if the Court approved the Elections Department, the remaining Department Heads would be requesting salary increases for their employees. He suggested that the matter be taken back to the Personnel Director to determine all the critical areas in all the Departments and noted that there would be additional funding matters, with other costs coming up, such as overtime requirements.

Commissioner Cascos noted that if the Bids would have been received before the Budget Process, the difference in the funds allocated for the printing of ballots would have gone into the General Fund or Operations and expressed concern as to the funding source if the Bids would have been higher.

Commissioner Valencia reiterated his support for the salary increases in the Elections Department, based on the importance of the upcoming Election.

Commissioner Benavides noted that the Elections Department was criticized for problems that occurred during Elections, but noted that employees were underpaid and expected to perform excellent work.

Judge Hinojosa stated that many of the employees in the Elections Department had received a significant percentage of increase, based on the \$865.00 cost of living increases and fringe benefits to the existing salaries. He stated that the Elections Department had not been overlooked when the cost of living adjustments were made and noted that the exception to salary increases were implemented through the Mid-Year Review Process. Judge Hinojosa explained that the Mid-Year Review Process had not been conducted in Fiscal Year 1999-2000, due to the lack of funding sources and added that the Budgets would be reviewed at mid-year based upon a salary equalization policy. He expressed his opposition as to the salary increases, but suggested that Request for Proposals be advertised for Consultant Services to create the Countywide Salary Matrix for the mid-year review process.

At this time, there was some discussion regarding the allocation of funds from the Departments for the Salary Matrix Consulting Services and the suggestion was made for the Request for Proposals to be developed and advertised by an appointed Committee.

Commissioner Cascos moved that the 2000 Fiscal Year Budget Amendment No. 2000-01, and the Salary Schedule for the Elections Administrator, Fund No. 100-4910, be **Tabled**, indefinitely.

The motion was seconded by Commissioner Matz and carried as follows:

(4) **PRESENTATION BY MR. KAMAL ARISS
REGARDING STATUS OF COUNTY JAIL
PROJECT**

At this time, Mr. Randy Hass, Landmark Construction Superintendent, stated that the building pad for the Sheriff's Office at the County Jail Site had been closed for the pouring of concrete which was scheduled for Monday, October 2, 2000, but noted that the concrete process had been delayed, due to the rainy weather. He stated that the process remained ahead of schedule and added that the frame work of the Sheriff's Office was approximately ten (10) days. Mr. Hass stated that the jail pad was about thirty percent (30%) complete with the select fill which would be completed within the next two (2) weeks.

Mr. Mark Yates, County Auditor, expressed concern as to the March/April completion date regarding discussions by the Computer Center of wiring telephones and the interest of moving into the Sheriff's Office earlier than the scheduled completion of the Jail. He stated that the building would be ready, but noted that the water and waste water services might not be available.

Mr. Hass stated that water and waste water services would be discussed with the Olmito Water Supply Corporation and would be requested to speed up the process.

Judge Hinojosa confirmed that the County was short on office space and added that the County was counting on the Sheriff's Department office space for other Departments.

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the Presentation by Mr. Randy Hass, Landmark Organization Construction Superintendent, regarding status of the County Jail Project was acknowledged.

(3) **APPROVAL OF MINUTES OF SEPTEMBER 20, 2000, SPECIAL MEETING, (TABLED OCTOBER 3, 2000), AND OCTOBER 3, 2000 (TABLED)**

Upon motion by Commissioner Matz, seconded by Commissioner Benavides and carried unanimously, the Minutes of the Special Meeting held September 20, 2000, at 1:30 P.M., were approved and the Regular Meeting held October 3, 2000, at 9:30 A.M., were **Tabled**.

(5) **AUTHORIZATION TO FILE THE FINAL BUDGET FOR FISCAL YEAR 2000-2001 WITH THE COUNTY CLERK'S OFFICE**

At this time, Mr. Mark Yates, County Auditor, noted that the Final Budget for Fiscal Year 2000-2001 to be filed with the County Clerk's Office would include the \$7.00 an hour minimum wage, the Juvenile Probation Officers' minimum salaries of \$26,500.00 and the cost of living adjustment, in the amount of \$730.00 plus benefits.

Commissioner Matz moved that the Final Budget for Fiscal Year 2000-2001 be filed with the County Clerk's Office.

The motion was seconded by Commissioner Cascos and carried unanimously.

The Fiscal Year 2000-2001 Budget is as follows:

(6) NOMINATION OF VALLEY PROUD ENVIRONMENTAL COUNCIL TO APPLY FOR A GENERAL LAND OFFICE, COASTAL MANAGEMENT PROGRAM CYCLE 6 GRANT, IN THE AMOUNT OF \$44,000.00 TO CONTINUE THE EDUCATIONAL CAMPAIGN OF ACAPTAIN CLEAN CRAB@ BEACH CLEAN UP PROGRAM FOR THE SPRING AND SUMMER OF 2002

Upon motion by Commissioner Benavides, seconded by Commissioner Valencia and carried unanimously, the nomination of Valley Proud Environmental Council to apply for General Land Office, Coastal Management Program Cycle 6 Grant, in the amount of \$44,000.00, to continue the Educational Campaign of ACaptain Clean Crab@Beach Clean Up Program for the Spring and Summer of 2002 was approved.

At this time, Commissioner Matz stated that the program was very successful and allowed funds to be utilized for the media to publicize the message prohibiting trash on the beaches, in English and Spanish. He noted that in addition to a continuance of the ACaptain Clean Crab@Program, the Valley Proud Environmental Council would include a request for specific grant assistance during the fall and spring beach clean ups on South Padre Island and Boca Chica Beach.

(7) APPROVAL TO OPEN INTEREST BEARING NOW ACCOUNTS WITH FIRST NATIONAL BANK

Commissioner Cascos moved that the following Interest Bearing Now Accounts be opened with First National Bank:

- a) Certificates of Obligation - Fund No. 040;
- b) Safe and Sober Program - Fund No. 480;
- c) Veterans Bond Debt Reserve - Fund No. 760; and
- d) Cameron County Employees Benefits - M.O.O.

The motion was seconded by Commissioner Matz and carried unanimously.

The Contracts are as follow:

(8) AUTHORIZATION TO PURCHASE TWELVE (12) MOBILE COMPUTERS FROM THE FISCAL YEAR 2001 EQUIPMENT LIST FOR THE DEPARTMENT OF ELECTIONS AND VOTER REGISTRATION

At this time, Mr. Robert Mendoza, Elections Administrator, explained that the twelve (12) laptops would replace the large paper list of registered voters utilized at the polling places by the Election Clerks and noted that in the past, there were problems with the printing quality of the paper lists which were detected after the lists were distributed.

Mr. Rudy Juarez, Chief Information Officer, expressed his concerns as to the specifications and configuration of the laptops requested by the Elections Administrator and noted that the quality of laptops would have limited usage and life span which would not be able to be utilized by other departments.

Mr. Wilson P. Bourgeois, Information Systems Coordinator, stated that the same type of laptops was utilized by the Federal Government and that the laptops would be able to be utilized by other departments.

Mr. Juarez reiterated his concerns as to the specifications of the laptop computers and noted that after the laptops were utilized by the Elections Department, the recommended standard upgraded laptops could be purchased by other departments.

Mr. Mendoza stated that the difference in savings from the laptops requested by the Elections Department, in the amount of \$12,000.00 and the laptops recommended by the Chief Information Officer, in the amount of \$25,000.00, could be utilized for other necessary items, such as a Department vehicle.

Judge Hinojosa suggested that the upgraded laptops recommended by the Chief Information Officer be purchased and that the request for a van in the Elections Department be discussed at a later date. He stated that replacing the paper lists with the laptops was a good idea and suggested that the Election Clerks be trained prior to receiving the laptops, in order to prepare for the upcoming Election.

Commissioner Matz requested that in the future, these types of issues should not be left till the last minute, noting that the matter should have been addressed much earlier.

Upon motion by Commissioner Valencia, seconded by Commissioner Cascos and carried unanimously, the purchase of twelve (12) standard mobile computers from the Fiscal Year 2001 Equipment List for the Department of Election and Voter Registration was approved.



(9) **AUTHORIZATION TO INCREASE THE CO-PAY
REGISTRATION FEES FOR CLINICAL HEALTH
SERVICES**

At this time, Ms. Yvette Salinas, Health Administrator, stated that the co-pay for the Immunization Program would remain at the rate of \$5.00, and that the Family Planning, Maternal and Well Child Services Fees would increase to \$8.00 per individual and a maximum of \$13.00 for family services.

Judge Hinojosa stated the additional revenues generated from the fees would be utilized for medical supplies and that any remaining funds would be allocated for the \$7.00 an hour minimum wage and cost of living adjustments for staff salaries which were funded by the State.

Ms. Salinas stated that the services were provided to individuals and/or families regardless of whether they could not afford the co-pay or had outstanding balances with the Health Clinic and added that the fees had not been modified since 1990.

Upon motion by Commissioner Matz, seconded by Commissioner Cascos and carried unanimously, the Co-Pay Registration Fees for Clinical Health Services were increased.

The Reports are as follow:

(10) APPROVAL OF THE CAMERON COUNTY PARKS SYSTEM RATES AND POLICIES

At this time, Mr. Javier Mendez, Parks System Director, stated that the rates had not been changed, due to the pending cable services in the park, but noted that the rates for the premium sites facing the gulf had increased during the peak seasons. He noted that a transaction fee, in the amount of \$2.00, for the credit card payment process had been added and stated that there had been problems concerning evacuation of the park and the amount of the refunds.

Commissioner Valencia expressed concern as to the unanimous vote by the Parks System Advisory Board and whether all the members were present, noting that the names of the members attending should be submitted to the Court.

Commissioner Matz questioned the \$1.00 late fee after the check out time on the last day of the reservation date and expressed concern as to the low rate of the late fee.

Mr. Mendez explained that if the occupants stayed over without notifying the Parks System, a late fee was charged, in the amount of \$1.00 on top of the daily rental fee.

Judge Hinojosa concurred that the penalty fees should be higher and suggested that the matter be referred back to the Parks Advisory Board to determine the late fee amounts.

Commissioner Matz moved that the Cameron County Parks System Rates and Policies be approved and that Item AF of the Rates and Policies be referred back to the Parks Advisory Board for a recommendation.

The motion was seconded by Commissioner Cascos and carried unanimously.

At this time, Judge Hinojosa reported that there had been complaints regarding the Parks System Toll Rates for motorcycles which were the same as the vehicle rates and suggested that the Parks Advisory Board review the rates which should be lower than vehicles, due to the number of passengers.

Commissioner Valencia questioned the status of the Engineering Services at the Santa Maria Community Building and Mr. Mendez stated that he had examined the building and found defects in the walls, but noted that the defects in the foundation were not visible.

Commissioner Valencia questioned when the County Engineer would address the building and stated that the structure of the building was becoming a big problem.

Judge Hinojosa stated that the Community Parks were not being maintained as expected and that the Parks should be kept in top shape to serve the local communities. He directed the County Engineer's Office to inspect the Santa Maria Community Building and inform the Court of the structural conditions of the building.



**(11) APPROVAL OF A RECREATIONAL PROGRAMS
CONTRACT BETWEEN BETTY OGLE AND
CAMERON COUNTY PARKS SYSTEM**

Commissioner Matz moved that the Recreational Program Contract between Ms. Betty Ogle and the Cameron County Parks System be approved.

The motion was seconded by Commissioner Cascos and carried unanimously.

The Contract is as follows:

(12) APPROVAL OF THE AGREEMENT BETWEEN CAMERON COUNTY AND SOUTHWESTERN BELL TO SET UP FRAME RELAY SERVICE

Commissioner Valencia moved that the Agreement between Cameron County and Southwestern Bell to set up Frame Relay Service be approved, said funding to be figured into a three (3) year budget cycle.

The motion was seconded by Commissioner Benavides and carried unanimously.

(13) APPROVAL OF A RESOLUTION IN SUPPORT OF A \$500,000.00 TEXAS BOOTSTRAP LOAN PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS BY THE COMMUNITY DEVELOPMENT CORPORATION OF BROWNSVILLE

Upon motion by Commissioner Cascos, seconded by Commissioner Benavides and carried unanimously, the Resolution in support of a \$500,000.00 Texas Bootstrap Loan Program Application to the Texas Department of Housing and Community Affairs by the Community Development Corporation of Brownsville was adopted.
