The meeting was called to order by Judge Pro-tem Pedro "Pete" Benavides at 9:30 A.M. He asked Reverend Bob Clark, Brownsville resident, for the invocation, and he then led the Court and audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on 28<sup>th</sup> day of October at 4:25 P.M.:

## **PRESENTATION**

(2) **PRESENTATION BY DR. VICTOR GONZALEZ, JR., MD, FAAFP, CAMERON COUNTY DEPARTMENT OF HEALTH AND HUMAN SERVICES HEALTH AUTHORITY REGARDING THE AVIAN FLU VIRUS (YS-HEALTH)**

Dr. Victor M. Gonzalez, Jr. M.D. F.A.A.F.P, presented and highlighted a reported regarding the Avian Flu Virus. He reported that the human cases that have been identified had direct contact with infected chickens and that the mortality rate was about 50%.

NOTE: JUDGE HINOJOSA ARRIVED AT THIS TIME.

Dr. Gonzalez explained that the mortality rate was due to lack of previous contact with the virus, which allows for the body to develop immunity. He reported that a vaccine was presently not available.

Judge Hinojosa asked what the timeline for a vaccine to be developed was.

Dr. Gonzalez responded that a vaccine should be available in about six months on a limited basis.

Commissioner Tamayo asked if any chicken farms in the U.S. have had to be destroyed.

Dr. Gonzalez responded negatively.

Commissioner Garza stated that the virus does not transmit from properly cooked chicken and that it was causing devastating effects to some areas because chicken farms must be destroyed upon the virus being detected.

Upon motion by Commissioner Tamayo, seconded by Commissioner Garza and carried unanimously, the Presentation by Dr. Victor Gonzalez, Jr., MD, FAAFP, Cameron County Department of Health and Human Services Health Authority regarding the Avian Flu Virus was acknowledged.

**(3) PRESENTATION BY JOE G. RIVERA, COUNTY CLERK, REGARDING THE 2006 UNITED WAY KICK-OFF. (MV-HUMAN RESOURCES)**

Mr. Joe G. Rivera, County Clerk, praised all county employees for giving over \$60,000.00 to United Way last year, and stated that this year counts fifty years of United Way being in existence. He introduced Mr. Al Villarreal, United Way Board Chairman, and Mr. Robert Rodriguez, South Padre Island Chief of Police.

Mr. Al Villarreal, United Way Board Chairman, introduced Mr. Robert Rodriguez as the 2006 United Way Fundraising Campaign Chairman.

Mr. Robert Rodriguez, South Padre Island Chief of Police, stated that United Way ensures that donations are used correctly, reason being why he accepted this challenge. He encouraged everybody to join the United Way Team because numbers make a difference.

At this time a video about our local United Way was presented.

Mr. Rivera informed that Mr. Armando Villalobos, District Attorney, would be the Drive Chairman and Mrs. Aurora de la Garza, District Clerk, would Co-chair the Drive. He presented his and the Human Resources Director's pledges.

Commissioner Garza moved that the Presentation by Joe. G. Rivera, County Clerk, regarding the 2006 United Way Kick-off be acknowledged.

The motion was seconded by Commissioner Tamayo and carried unanimously.

Mr. Mark Yates, County Auditor, presented the following late claims:

Judge Hinojosa asked if the amount being certified was gross revenue.

Mr. Mark Yates, County Auditor, responded in the affirmative, and explained that the \$608,105.00 was revenue for 50 additional federal inmates.

Judge Hinojosa asked what the cost would be for housing the additional inmates.

Mr. Yates stated that the cost for 200 additional inmates at \$0.95 per meal three times a day per would total \$190,713.00.

Commissioner Wood clarified that the meals were based on 500 inmates and the revenue was based on 50 additional inmates, thus there might be a cushion of \$150,000.00.

At this time there was a brief discussion regarding booking unused vacation.

Commissioner Garza commented that in essence overtime was being approved if vacation time was not being used by employees.

Upon motion by Commissioner Benavides, seconded by Commissioner Wood and carried unanimously, the notification to the Commissioners' Court of the Auditor's Certification of \$608,105.00 in additional Federal Inmate Revenue was acknowledged.

Mr. Mark Yates, County Auditor, expressed concern regarding the language of the item because not all information was posted.

Mr. Remi Garza, County Administrative Assistant, explained that the notice to the public was sufficient to inform the public of what would be discussed as required without having to post specific action. He added that the item presented by the auditor pertains to different matters therefore he split it up, those items relating to the creation of the positions, the payment of accumulated overtime and budgeting \$14,000.00 for miscellaneous. Mr. Garza stated that he felt that the notice was sufficient because the overtime issue was believed to be a budgetary issue and was included as such.

Mrs. Dylbia L. Jeffries, Contract Attorney, recommended that the second portion of the item be tabled.

Commissioner Garza stated that the overtime could be approved since it was included within the Budget Amendments.

Mrs. Jeffries advised against approval of this item.

Mr. Xavier Villarreal, Budget Officer, confirmed that payment of overtime was included within the backup information.

Mr. Yates informed that amounts for payroll checks were already being drafted; therefore, the approved overtime would be included in the following pay checks.

Judge Hinojosa clarified that the positions would no longer be funded from lapsed salaries since additional revenues were certified within item six.

Mr. Yates agreed.

Commissioner Benavides moved that the creation of 4 Detention Officer Positions, 3 Sergeant Positions and 2 Administrative Clerks for Department No. 1005120, Jail and Detention Facilities, be approved.

The motion was seconded by Commissioner Garza and carried unanimously.

**(9) CONSIDERATION AND POSSIBLE ACTION REGARDING ADDITIONAL RESPONSIBILITIES TO BE ASSUMED BY GEOGRAPHIC INFORMATION SYSTEM COORDINATOR AND CARTOGRAPHER AND SALARY ADJUSTMENTS. PS-DEPT. OF TRANSPORTATION)**

Mr. Pete Sepulveda, Department of Transportation Director, responded in the affirmative, and reported that the goal was to establish a customer list for the Solid Waste Division to match it to that of Red River Services Corporation to ensure that the number of accounts that Red River Services Corporation says they are serving matches the number of accounts that are making payments to the water corporation, cities or county, noting that the list would be maintained monthly. He added that they want to establish a GPS Tracking System for equipment and vehicles of the Public Works Division, perhaps doing so in phases. Mr. Sepulveda stated that they also want to complete a Road Inventory System Program for which approximately 75% of the information was available but they lack inputting and maintaining it. He explained that the intention was for Commissioners to be able to log on to view the status and maintenance history of every county road. Mr. Sepulveda stated that they also want to establish a Vehicle Maintenance Inventory System that accounts for every piece of equipment and vehicle owned by the county, in addition to a maintenance track record of the equipment and vehicles. He stated that they also want to establish a Building Permit Process that enables communications with the appraisal district. Mr. Sepulveda explained that this process could be done either by updating or replacing the present software.

Commissioner Benavides asked if the GPS Tracking System can read the location and speed of vehicles.

Mr. Sepulveda informed that he has worked with the Purchasing Agent and County Auditor, and that he would meet with vendors, adding that different features could be added once the system is in place.

Commissioner Benavides moved that the additional responsibilities to be assumed by Geographic Information System Coordinator and Cartographer and salary adjustments be approved.

The motion was seconded by Commissioner Garza and carried unanimously.
