(6) **CONSIDERATION AND POSSIBLE ACTION FOR COMMISSIONERS' COURT TO PRIORITIZE PROJECTS TO SUBMIT TO THE TEXAS DEPARTMENT OF TRANSPORTATION- STATEWIDE TRANSPORTATION ENHANCEMENT PROGRAM. (JM-PARK SYSTEM)**

Mr. Javier Mendez, Parks & Recreations Department Director, requested authorization to add the Rio Hondo Park and a ferry landing for the Isla Blanca as recommended by TX DOT.

Judge Hinojosa stated that the county would work with TX DOT on the ferry landing but they must provide funding.

Commissioner Garza asked how the two projects fit into the Park Master Plan and if this could be done without following procedure.

Mr. Mendez stated that according to Doyle Wells, the projects would fit in, and that the ferry would leave from the Banana Docks on Port Isabel, whom have been consulted.

Judge Hinojosa explained his understanding to be that the Santa Maria Welcome Center project would no longer be done.

Commissioner Tamayo explained that said project was included because the Bishop agreed to the terms set forth by the county but the documents were never prepared.

Mrs. Dylbia L. Jeffries, Contract Attorney, commented that she submitted a letter to the Bishop regarding the grant obtained by PD&M for this project indicating that time for the grant expired and that perhaps other grant could be applied for if they were still interested in doing something with the church.

Commissioner Tamayo added that the terms already discussed were stipulated in the letter.

Mrs. Jeffries clarified that the church had previously agreed to the terms.

Mr. Mendez added that Memorial Park Project would also qualify if tied to the trail being done by the City of Brownsville and requested that it be included.

Upon motion by Commissioner Garza, seconded by Commissioner Tamayo and carried unanimously, the prioritization of projects to submit to the Texas Department of Transportation – Statewide Transportation Enhancement Program was approved, inclusive of the Rio Hondo Park, the ferry landing at Isla Blanca and the Memorial Park Project.
