The meeting was called to order by Judge Pro-tem Pedro "Pete" Benavides at 9:42 A.M. He asked Reverend Bob Clark, Brownsville resident, for the invocation, and he then led the Court and audience in reciting the Pledge of Allegiance.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on February 10, 2006 at 3:41 P.M.:

(1) **PUBLIC COMMENTS**

None was presented.

PRESENTATIONS

(2) **PRESENTATION OF RESOLUTION RECOGNIZING REVEREND F. FELIBERTO PEREIRA FOR OUTSTANDING CITIZENSHIP. (COMM. COURT)**

At this time, Judge Hinojosa recognized Reverend F. Feliberto Pereira for his outstanding citizenship upon migrating to South Texas from Cuba where he was incarcerated for opposing Communism.

Reverend F. Feliberto Pereira thanked the Court for the recognition and for the liberty that our country offers. He prayed that Cameron County be blessed.

Upon motion by Commissioner Tamayo, seconded by Commissioner Benavides and carried unanimously, the Presentation of Resolution recognizing Reverend F. Feliberto Pereira for outstanding citizenship was acknowledged.

(10) **CONSIDERATION AND AUTHORIZATION TO PURCHASE AND FINANCE SPORTS LIGHTS FOR THE SANTA ROSA COMMUNITY PARK FROM MUSCO LIGHTING THROUGH TASB BUY BOARD. (JM-PARKS SYSTEM)**

Mr. Javier Mendez, Parks & Recreations Department Director, reported that a bid was received from Musco Lighting and requested that the same type of lighting be kept since it provide for power to be remotely accessed. He stated that the cost would total \$132,150.00 and that the company provides their own financing, adding that first payment could be delayed until October 1, 2006. He reported that the equipment could be delivered in four weeks and installed in two weeks.

Commissioner Benavides expressed concern with regards to lights turning off during a game.

Mr. Mendez explained that the lights are operated with the assistance of a computer (through the internet) or by calling the park directly and providing the pass word and in the event a game exceeds the time the lights are scheduled to shut off, then someone can call and will be provided with instructions on how to turn the lights back on.

Judge Hinojosa stated that he has spoken with the city and baseball officials of Santa Rosa about their concerns with sending their kids to other cities to play sports. He stressed the importance of families being able to

support and encourage their kids at games and the isolation that traveling from city to city creates as it keeps many parents from attending games.

Mr. Mendez added that in the proposal there is a ten year warranty with regards to the lights and the poles and the controlling is included in the cost. He noted that the cost of lighting has increased from \$85,000 to \$132,150 in a year period of two years.

Commissioner Wood expresses concern as to the interest rate of 6.6%.

Mark Yates, County Auditor, added that the interest rate is a bit higher than the County normally engages in, but the promissory note is for 6 months only.

Judge Hinojosa added that Laguna Madre Enhancement Group has given a check for \$50,000, which will be used in part to purchase the lighting.

On behalf of the Mayor of Santa Rosa, Mr. Ruben Ochoa, members of the Santa Rosa Community spoke on the fact that this investment is not only to benefit Santa Rosa, but all of Cameron County. They added that there have been requests to hold more tournaments, especially in the evenings, because of the quality of the park.

Upon motion by Commissioner Tamayo, seconded by Commissioner Wood and carried unanimously the Authorization to Purchase and Finance Sports for the Santa Rosa Community Park from Musco Lighting through TASB Buy Board was **approved**.

The Documentation is as follows:

(3) PRESENTATION OF A 120 DAY WORKPLAN FOR THE CAMERON COUNTY REGIONAL MOBILITY AUTHORITY. (PS-DEPT. OF TRANSPORTATION)

Mr. David Alex, CCRMA Chairperson, informed that the CCRMA has held monthly meetings with 100% participation by the Court's appointees. He stated that the CCRMA has much work to do and is leading other RMAs in the work it is doing.

At this time Mr. Pete Sepulveda, Department of Transportation Director/CCRMA Interim Executive Director, informed the Court of the progress the CCRMA has made since its inception which include adopting by-laws, procurement policies, conflict of interest policy for consultants, disadvantaged business enterprise policy statement, a drug and alcohol policy, selecting Estrada Hinojosa & Company, Inc. as the financial advisory services firm and selecting HNTB as the general engineering consultant. He spoke on different projects that the CCRMA is involved with which include the following: (1) Identifying 9 Pass Through Toll projects throughout Cameron County, (2) Negotiating identical Resolutions from the City of Port Isabel, the Town of South Padre Island and Cameron County regarding the proposed 2nd Causeway to South Padre Island and (3) working on the West Loop Environmental Assessment with TxDOT. He reported that a 120 day workplan was developed for the CCRMA; however, the Texas Department of Transportation requested that all work be done in 30 days and informed the CCRMA that weekly meetings would be needed in order to meet the deadline. He added that the reason for the time constraint is the fact that the Texas Department of Highway Commission will be holding their April monthly meeting in Brownsville on the 27th and the CCRMA would like to be on the agenda to have their Toll Equity Grant Applications considered and acted upon. Mr. Sepulveda reported that the CCRMA has the option of submitting a Toll Equity Grant Application either for both the West Loop Project and the 2nd Causeway or to submit two applications for the projects individually. He explained that the Toll Equity Grant Application for the 2nd Causeway would include a request for grant money to conduct the Environmental Impact Statement and the Toll Equity Grant Application for the West Loop Project would include 3 items: (1) design and engineering for the West Loop, (2) right of way acquisition and (3) requesting of grant money for the relocation of the rail. He let it be known that the CCRMA is in process of adopting administrative rules based on other RMAs and is in the process of completing the Level 2 Toll Feasibility Analysis.

Mr. Sepulveda informed the Court that the workshops for the CCRMA are held at the old Levi Building located in San Benito.

Commissioner Tamayo stated that she was happy and proud of the CCRMA appointees and all the work they are doing.

Commissioner Wood expressed appreciation for the work and efforts of the CCRMA Board Members.

Judge Hinojosa recognized Mr. David Alex as being a strong chairperson and expressed appreciation for his help and leadership. He suggested that the use and/or expansion of the Cameron County Airport be examined in order to use all available resources.

(15) **CONSIDERATION AND APPROVAL OF LOAN FROM THE INTERNATIONAL BRIDGE SYSTEM TO THE CAMERON COUNTY REGIONAL MOBILITY AUTHORITY (PS-DEPT. OF TRANSPORTATION)**

Mr. Pete Sepulveda, Department of Transportation Director/CCRMA Interim Executive Director, informed the Court that TxDOT does not provide any administrative or grant funds to assist RMAs when they are first established. He stated that the CCRMA is requesting \$250,000 for technical studies to advance the progress of the Toll Equity Grant Applications and to develop the strategic plan and public involvement plan. He informed the Court that the loan will be reimbursed through administrative funds.

Upon motion by Commissioner Tamayo, seconded by Commissioner Benavides and carried unanimously, the Approval of Loan from the International Bridge System to the Cameron County Regional Mobility Authority was **approved**.

(14) **CONSIDERATION AND POSSIBLE ACTION REGARDING OFFICE OF RURAL COMMUNITY OF AFFAIRS AWARD OF \$1 MILLION FOR THE 2005 TEXAS COMMUNITY DEVELOPMENT PROGRAM APPLICATION COLONIA EDAP FUND FOR NANCY, SOLISENO, SIERRA ALTO AND LA FERIA GARDENS AS PROPOSED BY THE CITY OF LA FERIA AND APPROVAL OF INTERLOCAL AGREEMENT. (COMM. COURT)**

Dylbia Jeffries Vega, Commissioners' Court Legal Counsel, clarified the terms of the agreement and they are as follows: Cameron County is considered the grantee of the monies, the County is going to contract with the City of La Feria to implement the program, the City of la Feria will handle all of the operations (i.e. bidding and negotiations with contractors, etc.), the County will submit all of the drafts for the monies to be paid out, the County will oversee the project and subsequently receive \$8,000.

Upon motion by Commissioner Wood, seconded by Commissioner Tamayo and carried unanimously, the agreement was **approved**.

(9) **CONSIDERATION AND APPROVAL OF A RESOLUTION OF THE COMMISSIONERS' COURT OF THE COUNTY OF CAMERON, TEXAS, PROVIDING TAX ABATEMENT TO CERTAIN HISTORICAL PROPERTIES INCLUDED IN THE 2006 CITY OF BROWNSVILLE HERITAGE PLAN. (FB-PD & M)**

Mr. Jose A. Gavito, City of Brownsville Heritage Officer, presented the 2006 City of Brownsville Heritage Plan which is in its 19th year. He noted that there are no changes being made from last year to this year. Mr. Gavito stated that research has been done as to the effects the Heritage Program has on the neighboring buildings.

He described several renovation projects that have been initiated because of their proximity to historic sites and they are: (1) A Mr. Yturria has completed 2 expansions across from a historic site; one is now valued at \$110,000 and the other at \$315,361, (2) Near the corner of 12th and Adams, there is a project under renovation that was valued at \$84,479 and is now valued at \$111,665, (3) On 12th and Washington, an apartment complex is under renovation that was valued at \$180,000 and is now at over \$200,000, (4) On the corner of 11th and Washington, a gentleman has renovated 4 apartment buildings that have increased in value from \$107,000 to \$135,000, (5) A young man purchased a small house for \$54,000 next door to the Gomez House on Levee St. and after a complete renovation he plans to sell it for over \$300,000, (6) A gentleman, who is retired from the Smithsonian Institute, bought a house across from The Gem that used to be a confederate post office for (2) years during the Civil War and is transforming the house into an art gallery. Mr. Gavito added that these types of renovations are only to the benefit of Brownsville and Cameron County.

Commissioner Tamayo moved that the resolution be approved. The motion was seconded by Commissioner Benavides and carried as follows:

Mr. David Garcia, Department of Transportation, asked if the Commissioners had any questions on the FY 2007 Cameron County Requests for Federal Funding.

Judge Hinojosa suggested scheduling a workshop on the West Rail Relocation Project and North Rail Relocation Project to update all of the Commissioners on the progress of the projects..

Mr. Garcia added that there will be a meeting on February 22nd, 2006 in regards to the projects and suggested to have the workshop on that same day, if not sooner.

Upon motion by Commissioner Benavides, seconded by Commissioner Tamayo and carried unanimously, the presentation was **acknowledged**.

Mr. David Garcia, Department of Transportation, stated that the resolution is currently being worked on.

Commissioner Wood questioned the sentence “Whereas, the \$2.6 million is less than a quarter of the \$10 million the USIBWC need to fund...” noting that \$2.6 million is actually a little more than a quarter of \$10 million.

Commissioner Benavides moved to approve the resolution with the change proposed by Commissioner Wood in regards to the mathematical error. The motion was seconded by Commissioner Tamayo and carried unanimously.

The Resolution is as follows:

Pete Sepulveda, Department of Transportation Director, clarified the exemption is to negotiate an agreement or contract with Dos Logistics, Inc. to help secure funding for the Levee Rehabilitation Program

Commissioner Tamayo moved to approve the exemption. The motion was seconded by Commissioner Benavides and carried unanimously.

Commissioner Wood motion to approve the Claims, inclusive of the late claim. The motion was seconded by Commissioner Tamayo and carried unanimously.

Mr. Villarreal stated that he sent out a memo and a copy of the request form to all departments and gave them 2-3 weeks to turn in their requests. At that time, the request should have been sent to him directly, but the District Attorney's Office sent their request to the computer center.

Upon motion by Commissioner Tamayo, seconded by Commissioner Wood and carried unanimously, the Authorization to Add Computer Equipment for the District Attorney's Office to the 2005-2006 Equipment List was **approved.**

Dylbia Jeffries Vega, Commissioners' Court Legal Counsel, asked to clarify the agreement made between Cameron County and the City of Brownsville/Brownsville Urban System with regards to the monies (\$21,177) and the implication that the County agreed to provide funding for more than one year and to fund more routes in the future.

Judge Hinojosa stated that the agreement was to fund the route in Cameron Park for one year only and if more funding was needed, the Commissioners' Court would evaluate the situation at that time.

Xavier Villarreal, Budget Officer, added that there are funds available for allocation, if the monies were needed at once.

Upon motion by Commissioner Benavides, seconded by Commissioner Wood and carried unanimously, the agreement was **approved**.
