The meeting was called to order by Judge Hinojosa at 3:15 P.M.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on November 13, 2006 at 2:38 P.M.:

(1) **CANVASSING OF PRECINCT ELECTION RETURNS FOR THE GENERAL ELECTION CONDUCTED ON NOVEMBER 7, 2006 AND IN ACCORDANCE WITH CHAPTER 67, CANVASSING ELECTIONS, SEC. 67.002, CANVAS OF PRECINCT RETURNS OF THE TEXAS ELECTION CODE. (RO-ELECTIONS)**

Mr. Roger Ortiz, Elections Administrator, presented the Court with the canvassing report. He noted that every third page under the tab identified as "Canvass Report" displays the total number of votes received by each candidate. He added that the "Detail by Pct." section of the report shows the election results in detail by each precinct.

Commissioner Garza inquired as to the exact number of persons that voted in the general election.

Mr. Ortiz informed the Court that the total number of votes cast was 60,514, which includes the General Election results as well as the Brownsville Independent School District Election results.

Judge Hinojosa asked how many votes were cast in the General Election only.

Mr. Ortiz responded that due to the votes being tabulated with the B.I.S.D. Election, the exact number is not available. He estimated that about 42,000 voted in the general election alone.

Upon motion by Commissioner Garza, seconded by Commissioner Tamayo and carried unanimously, the Canvassing of Precinct Election Returns for the General Election conducted on November 7, 2006 and in accordance with *Chapter 67, Canvassing Elections, Sec. 67.002, Canvas Of Precinct Returns* of the Texas Election Code was approved.

The Results are as follows:

There being no further business to come before the Court, upon motion by Commissioner Garza, seconded by Commissioner Tamayo and carried unanimously, the meeting was **ADJOURNED** at 3:25 P.M.
