The meeting was called to order by Judge Cascos at 5:04 P.M. He asked Pastor Andreas Lewis for the invocation. Judge Banalles then led the Court and audience in reciting the Pledge of Allegiance and the Pledge of Allegiance to the State Flag.

Judge Cascos thanked the RMA Board for their diligence and Commissioner Garza for his leadership concerning the I-69 corridor project.

Mayor Bill Card commented on the importance of I-69 for the economic development of the Valley and noted that he has been working on this project for (17) years. He thanked Mr. Pete Sepulveda, County Administrator, Mr. David Garcia, Deputy County Administrator, Mr. David Alex and Commissioner Garza for their devotion and attention to this project.
