(C) DISCUSSION AND POSSIBLE ACTION REGARDING THE TRANSPORTATION OF MENTAL HEALTH PATIENTS (PSJ-ADMINISTRATOR) (TABLED)

Commissioner Wood motioned to TABLE this item.

The motion was seconded by Commissioner Tamayo and carried unanimously.

(D) DISCUSSION AND POSSIBLE ACTION REGARDING THE COUNTY'S STATE AND FEDERAL LEGISLATIVE AGENDA. (PSJ-ADMINISTRATOR)

Mr. David Garcia, Deputy County Administrator, informed the Court that preliminary information has been received in advance of Thursday's TxDOT Commission Meeting regarding the County's Third Call Border Colonia Access Project. He reported that (3) competitive projects which were awarded funding included El Ranchito (\$927,256), Cameron Park (\$6.6 million) and Las Palmas (\$1.9 million).

Judge Cascos noted that the initial request for Cameron Park was \$11 million for 8.3 miles and only \$6.6 million was awarded and questioned whether the project will have to be scaled back.

Mr. Garcia replied that staff will have to re-evaluate the project to determine what work can be done with the amount allocated. He also reported the non-competitive project allocations: Glenwood Acres (\$358,673), Villa Del Sol (\$218,552), Villa Pancho (\$204,963), Grande Acres (\$205,653), Las Yescas (\$118,247), Colonia Iglesia Antigua (\$251,149), Graham Subdivision (\$276,849), Laguna Escondida Heights #2 (\$138,176), Illinois Heights (\$456,067), Laguna Escondida Heights (\$140,859), Alto Real (\$60,925), La Feria Gardens (\$139,674), Reed Hope King (\$322,255), Bonaville Terrace (\$317,267) and La Paloma Townsite (\$475,027) with the total amount allocated being \$3,684,336.

Mr. Garcia announced that on July 31, 2008, the Brownsville Economic Development Council will be holding a Trade Forum and has invited Cameron County to attend.

Commissioner Tamayo motioned to acknowledge the Report by David Garcia regarding the County's State and Federal Legislative Agenda.

The motion was seconded by Commissioner Wood and carried unanimously.

There being no further business to come before the	Court, upon motion by Commissioner Tamayo
seconded by Commissioner Benavides and carried unanimously,	the meeting was ADJOURNED at 5:17 P.M.
