





Commissioner Tamayo motioned to TABLE this item.

The motion was seconded by Commissioner Wood and carried unanimously.

(H) PUBLIC HEARING TO DISCUSS GRANT FUNDING AND POSSIBLE USE OF FUNDS FOR THE 2009 JUSTICE ASSISTANCE GRANT (JAG) FROM THE U.S. DOJ'S BUREAU OF JUSTICE ASSISTANCE. (FB-PD&M)

Commissioner Garza motioned to open the Public Hearing.

The motion was seconded by Commissioner Tamayo and carried unanimously.

Mr. Frank Bejarano, PD&M Director, stated that the County's 2009 JAG allocation amounts to \$124,000 and presented a list of project requests to the Court for review.

Judge Cascos recommended that any project requests for personnel be excluded from consideration.

Ms. Patricia Hernandez, Magistrate Court, presented a request for video-conferencing equipment that would allow the Magistrate Court Judges to perform magistrations from locations outside of the Courtroom.

Mr. Charles Hoskins, Emergency Management, presented a funding request which included an incident management & command system software, an emergency response trailer, radios, communication equipment for the deaf and satellite mobile phones.

Constable Precinct 2 Pete Avila presented his project request for mobile radios and mobile units totaling \$20,000.

Ms. Nelly Bermudez, Court Coordinator for Justice of the Peace 2-1, presented a funding request for (1) computer totaling \$1,525.47.

Mr. John Keener, Deputy Constable for Constable Pct. 3, presented a funding request which included mobile computers, overhead lights for two units, portable and mobile radios and flashlights totaling \$83,719.82.

Commissioner Garza asked for clarification as to the discrepancy in the amount requested for portable radios between Constable Pct. 2 and Constable Pct. 3.

Mr. Charles Hoskins replied that the model of the portable radio may be the reason.

Commissioner Garza recommended that the portable radios be uniform County-wide.

Mr. Rene Garza, District Attorney's Office, explained the request for the District Attorney's Office.

Judge Cascos noted that project requests that are not personnel-related total \$371,000 and recommended excluding the \$156,000 request from the Sheriff's Office and then working with department to prioritize requests.

Captain Javier Reyna, Sheriff's Office, asked to amend the Sheriff's Office request to ten overhead lights in lieu of 20 vehicle digital cameras.

Commissioner Garza motioned to close the Public Hearing.

The motion was seconded by Commissioner Benavides and carried unanimously.
