Mr. Robert L. Lopez, Director of Administrative Services, presented the Energy Conservation Program for Cameron County and stated that the main objective is to reduce energy consumption and to improve energy efficiency.

Mr. Lopez explained that the Energy Conservation Program includes implemented projects such as reduction in energy costs and retro fitting all lights and ballasts.

Commissioner Tamayo informed Mr. Lopez that she has been advised that lights are being left on overnight at the Harlingen Annex.

Mr. Lopez replied that he will look at the possibility of using motion sensor lighting at the Harlingen Annex. He further explained that projects to be implemented include installing solar lighting at new parks and boat ramps, a solid waste evaluation of each County building and implementing an electronic agenda system. He discussed Phase One of the Energy Conservation Program, a complete assessment of energy conservation and facility optimization, and Phase Two, initiating the Energy Program at each County building.
