He recommended that the County reapply on behalf of the Town of Rancho Viejo in the amount of \$61,171.

Mr. Bejarano stated that \$41,497 is also available for reallocation as Palm Valley applied for funding and later withdrew their application. He informed the Court that Indian Lake is requesting \$7,100 for one of their projects and recommended that the funding be taken from the amount that was previously allocated to Palm Valley.

Judge Pro-Tem Garza recommended that the remaining balance from the \$41,497 be utilized to repair Dilworth Road.

Mr. Bejarano suggested that the Court approve a "back-up" project in the event that the remaining projects are not accepted and recommended that any funding available be used to repair County roads.

Commissioner Tamayo motioned to authorize the County to reapply for funding on behalf of the Town of Rancho Viejo in the amount of \$61,171 and that \$7,100 be awarded to Indian Lake from the \$41,497 available and that the remaining balance be applied toward repairing County roads that were damaged by Hurricane Dolly, specifically Dilworth Road.

The motion was seconded by Commissioner Wood and carried unanimously.
