Ms. Canales responded that there is one individual whose primary job is to monitor bankruptcy accounts.

Judge Cascos asked to see a budget-to-actual comparison as to the total delinquent tax collections.

Commissioner Tamayo motioned to acknowledge the Presentation by Linebarger, Goggan, Blair & Sampson, LLP, Law Firm regarding the Cameron County Delinquent Property Tax Collections.

The motion was seconded by Commissioner Benavides and carried unanimously.
