The meeting was called to order by Judge Sepulveda at 9:00 A.M. He then asked for a moment of silence.

The Court then led the audience in reciting the Pledge of Allegiance and the Pledge of Allegiance to the State Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on May 4, 2015 at 8:48 a.m.:

Commissioner Dominguez motioned to approve the “Consent Items”.

The motion was seconded by Commissioner Benavides and carried unanimously.

She brought it to the attention of the Court that Warrant No. 00341535, in the amount of \$79.62, is payment to TxTag for toll way violations on County vehicles and noted that, in the past, reimbursement was requested from those individuals who were driving the County vehicles when the violation occurred.

Commissioner Benavides recommended that the toll violations be paid.

Judge Sepulveda directed staff to be consistent as to how this matter was handled in the past.

Ms. Galarza asked the Court to VOID Warrant No. 00341273, Warrant No. 00341282, Warrant No. 00340893, Warrant No. 00341557, Warrant No. 00341502, Warrant No. 00341442 and Warrant No. 00340644.

Commissioner Dominguez inquired as to Warrant No. 00341559 made payable to Michael's Store.

Ms. Galarza replied that the claim is payment for custom framing for resolutions to be presented by the Court.

Commissioner Benavides stated that she paid \$404.78 for the custom framing.

Ms. Galarza explained that an invoice was turned in for payment and suggested tabling this claim until the next Meeting.

Commissioner Dominguez motioned to approve the Claims as presented.
