ABSENT:

The meeting was called to order by Judge Sepulveda at 8:45 A.M. He then asked for a moment of silence.

Mr. Xavier Villarreal then led the Court and audience in reciting the Pledge of Allegiance and the Pledge of Allegiance to the State Flag.

The Court considered the following matters as posted and filed for Record in the Office of the County Clerk on August 31, 2015 at 8:19 a.m.:

(1) **PUBLIC COMMENTS.**

Mr. Oscar Martinez, with Valley Interfaith, commented on the tax rate and asked that a plan be developed,

specifically regarding public lighting, if a tax rate increase is to be approved.

Ms. Mary Helen Flores spoke in opposition to the tax abatement for LNG.

Ms. Yvonne Peck commented on the selection of the grievance committee and asked the Court to deny the tax abatement for LNG and to not raise taxes.

Ms. Ruth Hernandez commented on the tax rate and mentioned that many of her neighbors have lost their homes because they are unable to pay their taxes.

(3) ACTION ITEMS.

(S) DISCUSSION AND POSSIBLE ACTION REGARDING THE 2015-2016 FISCAL YEAR BUDGET. (MG-AUDITOR)

Mr. Xavier Villarreal presented the most recent budget projections and asked the Court for their recommendations.

Commissioner Sanchez recommended a \$1,000 discretionary allowance for non-law enforcement, a 10% salary increase for all law enforcement and to include the budget requests for the Civil Division and Elections Department.

Judge Sepulveda expressed support with a three to three-and-a-half percent salary increase across the board and noted that he is against any proposal that will utilize Fund Balance.

Commissioner Sanchez inquired as to the number of days the County has in reserves.

Mr. Villarreal replied that the bond companies recommend (90) days and the County currently has (92)

days.

Commissioner Garza suggested a 3.5% salary increase across the board and expressed his opposition for using Fund Balance.

Commissioner Benavides stated that she does not want to jeopardize the County's bond rating and spoke in support of a 4% increase across the board.

NOTE: Commissioner Sanchez exited the Meeting at 9:53 A.M.

Commissioner Garza motioned to approve Column "K" which includes the toll rate increases, certification

of Constable revenues, a 4% increase across the board, Juvenile Probation at approximately \$157,000, (1) deputy constable each for Constable Precincts No. 2, 4 and 5, JP Court staff at a total increase of 5%, Court at Law Records Coordinator equalization, the increase for the Civil Division, the Elections Office Matrix, the \$5,000 back to the position in Emergency Management, and a 5% total increase for the Magistrate Court Administrator.

The motion was seconded by Commissioner Benavides and carried unanimously.
